1. The Professional Regulation Commission (PRC) intends to apply the sum of **ONE MILLION SEVEN HUNDRED EIGHTY-THREE THOUSAND ONE HUNDRED FORTY PESOS (Php1,783,140.00)** being the Approved Budget for the Contract (ABC) for the Procurement of PRC– Cordillera Administrative Region (PRC CAR) Security Services for the Year 2019 - 2021. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Professional Regulation Commission – Cordillera Administrative Region now invites bids for Procurement of PRC - CAR Security Services. Security Services contract starts in 2019 - 2021. Bidders should have completed for the past two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
4. A complete set of Bidding Documents may be purchased by interested Bidders starting on July 22, 2019 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **ONE THOUSAND PESOS (Php1,000.00)**.
5. Bids must be delivered to the address below on or before August 13, 2019, 5:00 pm. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.  
  
**OPENING AND PRELIMINARY EXAMINATION OF BIDS** shall be on August 14, 2019 at 10:00AM at the PRC Conference Room, 5<sup>th</sup> Floor, Pine Lake View Building, NO. 09 Otek Street corner Benjamin R. Salvosa Drive, Rizal Monument, Baguio City. Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address below. **LATE BIDS SHALL NOT BE ACCEPTED.**
6. The contract to be awarded to the winning bidder shall be for a period of two years starting in 2019 - 2021.
7. The PRC-CAR reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
