The Professional Regulation Commission (PRC) announces that **40** out of **86** passed the **Landscape Architect Licensure Examination** given by the **Board of Landscape Architecture** in **Manila** this **July 2018**.

Starting **July 11, 2018**, registration for the issuance of Professional Identification Card (ID) and Certificate of Registration will be done on-line. Please go to www.prc.gov.ph and follow instructions for initial registration. Those who will register are required to bring the following: downloaded duly accomplished Oath Form or Panunumpa ng Propesyonal, notice of admission (for identification only), 2 pieces passport sized pictures (colored with white background and complete name tag), 2 sets of documentary stamps and 1 piece short brown envelope. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The date and venue for the oathtaking ceremony of the new successful examinees in the said examination **WILL BE ANNOUNCED LATER.**
