## PROFESSIONAL REGULATORY BOARD OF MEDICAL TECHNOLOGY RESOLUTION NO. 25 Series of 2024

## APPROVAL OF APPLICATIONS FOR REGISTRATION WITHOUT EXAMINATION AS MEDICAL LABORATORY TECHNICIANS

WHEREAS, Section 21(3)<sup>1</sup> of Republic Act (R.A.)
