





- Price quotation/s must be denominated in Philippine peso and shall include all taxes, duties and/or levies payable.
- All quotations exceeding the approved budget for the contract shall be automatically rejected.
- Any erasures or overwriting shall be valid only if they are properly signed by you or your duly authorized representatives.
- Payment shall be made through our Government Servicing Bank, the Land Bank of the Philippines, after delivery and upon the submission of the required supporting documents, i.e., order slip and/or billing statement, by the contractor. Please note that the corresponding bank transfer fee, if any, shall be chargeable to the contractor's account.
- In order to assure that manufacturing defects shall be corrected by the supplier, a warranty security shall be required from the contract awardee for a minimum period of three (3) months, after acceptance by the Procuring Entity of the delivered supplies, per Section 62.1 of the 2016 Revised IRR. The obligation for the warranty shall be covered by either retention money in an amount equivalent to at least one percent (1%) of every progress payment, or a special bank guarantee equivalent to at least one percent (1%) of the total contract price. The said amounts shall only be released after the lapse of the warranty period or, in the case of Expendable Supplies, after consumption thereof: *Provided, however, that the supplies delivered are free from patent and latent defects and all the conditions imposed under the contract have been fully met.*

**TERMS OF REFERENCE (TOR)**

**PROVISION OF INTERNET CONNECTION AND IP VPN UPGRADE (2023)**  
(Through Negotiated Procurement Pursuant to Section 50 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184)

**I. APPROVED BUDGET FOR THE CONTRACT**

The supplier shall bid for the item described in this Terms of Reference, which shall not exceed the Approved Budget for the Contract (ABC) in the amount of Eighteen Million Four Hundred Thirty-Tree Thousand Nine Hundred Seventy-Seven Pesos and Ninety-One Centavos (Php18,433,977.91) inclusive of all applicable bank and government charges.

**II. SPECIFICATION**

**A. Service Provider Requirements:**

- BIDDER shall certify that the cable facility being used in the connectivity between the bidder's circuits is exclusively owned and operated by the bidder; all last-mile facilities must be wired cable.
- BIDDER shall provide a certification that they are connected or subscribed to Tier 1 or Tier 2 networks or ISPs.
- BIDDER shall provide a certification that it uses its domestic nationwide network and operates its landing stations, at least 3 cable landing stations
- BIDDER directly connects to the Asia Pacific and US Peering partners.
- BIDDER shall provide a certification that its network platform is compliant with the latest MEF carrier Ethernet (2.0).
- BIDDER shall have at least 3 Cisco Certified Internetworking Experts, 8 MEF Carrier Ethernet Certified Professionals 2.0, and certified Project Management Professionals (PMP) Technical support personnel.
- BIDDER shall support or IPV6 ready and compliant.
- BIDDER shall provide a certification that it uses IPVPN Network that is supported by a nationwide Domestic Fiber Optic Backbone Network to ensure fast and reliable service across the nation and the bidder must own the facility.
- BIDDER shall provide SNMP Community string on every route.
- BIDDER shall install or set up a new conduit in case the existing and/or new Service Center locations are not equipped in handling fiber-optic lines.


