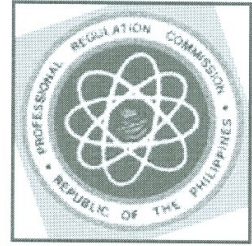

NOTICE OF AWARD OF CONTRACT FOR SECURITY SERVICES 2019

Please be informed that upon recommendation of the Regional Bids and Awards Committee (RBAC), the Contract for the Security Services 2019 for PRC Legazpi Regional Office is awarded to Hydro Vision Security Agency (HVSA) as the Single Calculated and Responsive Bidder with the submitted bid price of Eight Hundred Eighty Six Thousand Seven Hundred Eight Pesos and Fifty Six Centavos Only (P886,708.56), pursuant to Section 37 of Republic Act No. 9184.

Hydro Vision Security Agency (HVSA) is therefore, required to sign a contract with the Commission within ten (10) calendar days from receipt of this Notice of Award. The Commission shall issue a Notice to Proceed within seven (7) calendar days from the signing of the contract.

To guarantee faithful performance of its obligation under the contract, HVSA is required to post a Performance Security payable to the PRC upon signing of the Contract in accordance with form and amount prescribed in section 39.1 of the Implementing Rules and Regulations of Republic Act No. 9184. The Performance Security is subject to forfeiture in favour of PRC in the event it is established that HVSA is in default of any of its contractual obligations.

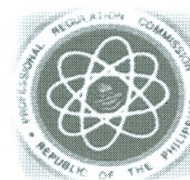

**RECOMMENDING TO THE PROFESSIONAL REGULATION COMMISSION
REGIONAL OFFICE V (PRC-ROV) REGIONAL DIRECTOR/HEAD OF THE
PROCURING ENTITY THE AWARD OF THE CONTRACT FOR SECURITY
SERVICES OF PRC LEGAZPI REGIONAL OFFICE FOR THE YEAR 2019 TO
HYDRO VISION SECURITY AGENCY (HVSA), WITH THE BID AMOUNT OF EIGHT
HUNDRED EIGHTY SIX THOUSAND SEVEN HUNDRED EIGHT PESOS AND FIFTY
SIX CENTAVOS ONLY (P886,708.56)**

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the Bids and Awards Committee (BAC) Bulletin Board for the project: Provision of Security Services 2019, Hydro Vision Security Agency and Hi-Tone Security Agency, Inc. participated in the Public Bidding for the Security Services of PRC Legazpi Regional Office for the Year 2019 WITH THE APPROVED BUDGET FOR THE CONTRACT OF NINE HUNDRED SIX THOUSAND PESOS ONLY (P906,000.00);

WHEREAS, on May 6, 2019, during the Submission and Opening of Bids, Hydro Vision Security Agency submitted their official bid at 9:38 a.m. while Hi-Tone Security Agency submitted their Bids at 11:36 a.m. The BAC Secretary did not accept their official bid and has been disqualified outright; for they failed to comply with the deadline of submission of bids published in the Invitation to Bid which is 10:00 a.m. of May 6, 2019.

WHEREAS, *Section 25, of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act – A bid shall have two (2) components, namely the technical and financial components which should be in separate sealed envelopes, and which shall be submitted simultaneously. The bids shall be received by the BAC on such date, time and place specified in the invitation to bid. The deadline for the receipt of bids shall be fixed by the BAC, giving it sufficient time to complete the bidding process and giving the prospective bidders sufficient time to study and prepare their bids. The deadline shall also consider the urgency of the procurement involved.*

Bids submitted after the deadline shall not be accepted

WHEREAS, during the opening and evaluation of the bid documents on May 6, 2019 at 1:00 p.m. held at the Conference Room of PRC Regional Office, Hydro Vision Security Agency passed its respective eligibility and technical requirements; the BAC proceeded in the opening of their financial bid proposal with the Bid amount of Eight Hundred Eighty Six Thousand Seven Hundred Eight Pesos and Fifty Six Centavos (P886,708.56).

WHEREAS, Hydro Vision Security Agency as a lone bidder was declared to be the Single Calculated Responsive Bidder and was subjected to post qualification

process to determine its compliance with all the requirements and conditions for eligibility specified in the bidding documents.

WHEREAS, a site inspection was conducted at Hydro Vision Security Agency Office at No. 37-1 Jacinto Street, Brgy 6, Bañadero Pob. Old Albay, Legazpi City on May 9, 2019 for post qualification to verify, validate and ascertain all statement made in its Eligibility and Technical Bid Envelopes submitted during the submission and opening of bids, including the additional requirements submitted by the bidder and;

WHEREAS, Hydro Vision Security Agency having passed the post qualification, was declared to be the Single Calculated and Responsive Bidder (SCRB).

WHEREAS, Section 12 of R.A. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.

WHEREFORE, the Regional Bids and Awards Committee (RBAC) RESOLVES, as it hereby RESOLVED, to recommend the award of the contract for Security Services of PRC Legazpi Regional Office for the year 2019 to Hydro Vision Security Agency, WITH THE BID AMOUNT OF EIGHT HUNDRED EIGHTY SIX THOUSAND SEVEN HUNDRED EIGHT PESOS AND FIFTY SIX CENTAVOS ONLY (P886,708.56).
