DESIGNATION OF THE MEMBERS OF THE QUALITY ASSURANCE REVIEW COUNCIL

WHEREAS, on 29 July 2024, the Professional Regulatory Board of Accountancy (Board) and the Philippine Institute of Certified Public Accountants (PICPA) signed a Memorandum of Agreement (MOA) paving the way for the full implementation of the Quality Assurance Review (QAR) program:

WHEREAS, under Section 3 (b.1) of the MOA, the Board and PICPA shall form the QAR Council to be composed of four (4) members from PICPA and one (1) from the Board, and the designation of an Alternate Member to be selected from its incumbent members;

WHEREAS, in during its regular monthly meeting held on 12 August 2024, the Board approved the designation of SAMUEL B. PADILLA and GLORIA T. BAYSA, as its regular member and alternate, respectively in the QAR Council;

WHEREAS, pending the amendments of the 2023 Revised Rules on the QAR program to conform with the terms and conditions in the said MOA, it is imperative to convene the new composition of the QAR Council so that it can already review, draw and act on important standard operating procedures, and policies for the smooth implementation of the QAR program.
