PROFESSIONAL REGULATORY BOARD OF ACCOUNTANCY Resolution No. <u>54</u> Series of 2024

ADOPTING THE AUDITING AND ASSURANCE STANDARDS COUNCIL PRONOUNCEMENTS AS PART OF THE PHILIPPINE AUDITING STANDARDS

WHEREAS, the Auditing and Assurance Standards Council (AASC) has approved and submitted the following pronouncements to the Professional Regulatory Board of Accountancy (Board) for approval:

- 1. Narrow Scope Amendments to PSA 700 (Revised), Forming an Opinion and Reporting on Financial Statements;
- 2. PSA 260 (Revised), Communication with Those Charged with Governance, as a Result of the Revisions to the Code of Ethics for Professional Accountants in the Philippines that Require a Firm to Publicly Disclose When a Firm Has Applied the Independence Requirements for Public Interest Entities (PIEs)

WHEREAS, after study and review of the provisions of the above-stated pronouncements as adopted by the AASC, the Board finds them to be well-taken and instructive for compliance by practicing Certified Public Accountants;

WHEREFORE, the Board RESOLVES, as it is hereby RESOLVED, to adopt the abovestated pronouncements as part of the Philippine Auditing Standards.

RESOLVED FURTHER, that this Resolution and the above-stated pronouncements shall take effect after fifteen (15) days following its publication in the Official Gazette or in any newspaper of general circulation in the Philippines.
