DESIGNATION OF OCCIDENTAL MINDORO; ORIENTAL MINDORO; ROMBLON; PALAWAN CITY; CATARMAN, NORTHERN SAMAR; AND VIRAC, CATANDUANES AS ADDITIONAL TESTING CENTERS FOR THE SEPTEMBER 2018 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS (LEPT)

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the PRC Modernization Act of 2000 vests upon the Professional Regulation Commission (Commission) the power to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate; **to determine and fix the places and dates of examinations;**

WHEREAS, in the exercise of this mandate, the Commission issued Resolution No. 2017-1068 and 2017-1080 (A) fixing the dates and places of the professional licensure examinations for calendar year 2018, with the Licensure Examination for Professional Teachers (LEPT) to be held on September 30, 2018 in the Cities of Manila, Zamboanga, Bacolod, Rosales, Pangasinan, Laoag and General Santos City, and in all PRC Regional Offices;

WHEREAS, PRC Resolution No. 2012-675 prescribes the guidelines on the designation of additional testing centers for the LEPT;

WHEREAS, there were requests for the conduct of the September 2018 LEPT in Occidental Mindoro; Oriental Mindoro; Romblon; Palawan City; Catarman, Northern Samar; and Virac, Catanduanes;

WHEREAS, the Professional Regulatory Board for Professional Teachers (Board) endorsed the approval of the above requests per its March 12, 2018, May 22, 2018 and May 25, 2018 Memoranda to the Commission.

NOW THEREFORE, on motion duly made and seconded, the Commission hereby **RESOLVES** to designate Occidental Mindoro; Oriental Mindoro; Romblon; Palawan City; Catarman, Northern Samar; and Virac, Catanduanes as additional testing centers for the September 2018 LEPT.

This Resolution shall take effect upon approval.
