#### Preliminary Article

Pursuant to the provisions of Section 5 and 10 of R.A. No. 5680, otherwise known as the "Fhilippine Physical and Occupational Therapy Law", the following rules and regulations are hereby promulgated:

• Definition of Terms. - As used in this Act, the following terms shall mean:

(a) Enysical therapy is the art and science of treatment by means of therapeutic exercises, heat, cold, light, water, manual manipulation, electricity, and other physical agents.

(b) Physical therapy technician is a person, who not having acquired a bachelor's degree in Physical Therapy is qualified through in-service training and practical experience to assist in the application of physiotherapeutic procedures and to undertake specific assignments as directed by a qualified physical therapist in carrying out the prescription of a licensed physician. Such assignments shall be confined within the limits of a hospital or institution of employment.

(c) Rehabilitation medicine, at the patient level, is the "clinical management of the problems associated with disability with the objective of improving to the maximum level the physical, socio-economic and physiological functioning of a disabled individual. Medical rehabilitation is an integral part of total medical care. Total rehabilitation is best achieved through the coordinated work of various health disciplines like medicine, psychology, social work, physical therapy, occupational therapy, speech and hearing, nursing, vocational evaluation, dietetics, and special education,"

(d) Physical therapist is a person legally qualified and licensed to practice physical therapy under this Act.

(e) Physiatrist is a legally qualified and licensed physician specializing in the practice of rehabilitation medicine.

(f) Occupational therapy is a paramedical discipline concerned with the administration of medically prescribed treatment, in the form of supervised activity, to persons disabled by disease or injury. The objective of occupational therapy is to contribute to the development of the disabled person's independence, to improve his emotional, social, and physical well-being and his ability to care for himself both at home and on the job, and to begin early evaluations and experimentation for future job training and employment.

Occupational therapy may be prescribed by a general medical practitioner or a specialist in any of the recognized branches of Pursuant to the provisions of Section 5 and 10 of R.A. No. 5680.

(g) Occupational therapist is a legally qualified person licensed to practice occupational therapy under this Act and who by accepted academic training and professional clinical experience possesses the knowledge and skills to achieve the objectives as defined and set by the occupational therapy profession. The occupational therapist functions through the use of the basic methods, approaches and procedures of occupational therapy (creative, manipulative, educational, pre-vocational evaluation and self-care activities) which are designed to assess and develop the actual and potential abilities of the individual.

The occupational therapist plans, organizes, evaluates, and participates in a medically oriented treatment program to assist the disabled person towards physical independence, productivity, and constructive personal or social relationship.

The occupational therapist functions in general and special hospitals, rehabilitation and welfare centers, pediatric clinics, psychiatric clinics, specialized schools, geriatric institutions, home care programs, and work-adjustment units.

(h) Occupational therapy technician or assistant is a person who, not having acquired a bachelor's degree in occupational therapy, is qualified, as determined by a bona fide national professional association of occupational therapists in the Philippines through in-service training and practical experience, to function as an assistant to and under the direct supervision of an occupational therapist to assist in rehabilitating patients in hospitals and similar institutions.

(i) Disability is a loss or reduction of a person's capacity to effectively cope with the demands of his environment as a result of disease or injury, including birth trauma.

In addition to the subjects mentioned in letter (e) an applicant in the physical therapy examination must also submit an evidence or certification that he or she had completed at least nine months of internship in Physical Therapy in an adequate Physical Therapy Department of a hospital or clinicduly certified by the Department of Health. An applicant in the Occupational therapy examination must also submit, an addition to the subjects mentioned in letter (f), evidence of a clinical experience of nine months at least rendered under the supervision of a competent and duly registered occupational therapist in an accredited hospital or institution duly signed by the Head thereof, however, this requirement shall not be applicable to the first batch of examinees before the roster of registered physical therapists or occupational therapists has been established. For the first applicants in the examination a certification of the Head of hospital duly accredited by the Department of Health of the clinical experience will suffice. Clinical experience shall include the effective treatment of psychosocial and physical dysfunctions of patients of wide age range and of both sexes.

The examinations for the practice of physical therapy and occupational therapy in the Philippines shall consist of <u>written</u> and <u>practical</u> phases. The Board shall prepare and publish the schedule of subjects both in the written and practical examinations within the scope of the subjects of the main course of the physical therapy and occupational therapy as the case may be, to be approved by the Office of the President at least two months before the date of the examination. In case the Board will decide to change the schedule and title of the subjects to be given in future examinations, the same shall be submitted for approval by the Office of the President and shall be published at least two (2) months before the date of the coming examination.

In order to pass the first physical therapist or occupational therapist examination, a candidate must obtain a general rating of not below seventy-five per cent in the written examination with no rating below sixty per cent in any subject and a general rating of at least 75 per cent also in the practical examination. A candidate who passes the theoretical (written) but fails in the practical examination may be permitted to take a re-examination in the practical examination only and vice-versa. Any applicant who failed in the first examination but obtained seventy-five per cent in each of at least five of the theoretical subjects may be permitted to take a second examination within one year from the date of the first examination, only on the subjects wherein he received a rating below seventy-five per cent each. In order to pass in the second examination, the examinee must obtain a rating of not below seventy-five per cent in each of the subjects repeated: Provided, That' an applicant who failed in the set of subjects repeated in the second written examination must take a re-examination in all the subjects within one year from the date of the second examination: Provided, further, That should he still fail in the third re-examination, the applicant shall be required to undertake a prescribed course of study and to show proof of the completion of such course before he will be admitted to the fourth examination. the same as these h at the the track

#### Sec. 7. Report of Ratings in the Examination:

It is the responsibility of the examiner to rate the papers of the candidates pertaining to the subjects assigned to him. The same shall be rerated by at least one other examiner.

The Board shall, within 120 days after each examination, report the ratings obtained by each candidate to the Commissioner of Civil Service, who shall, with his recommendation, submit such ratings to the President for his approval.

# Sec. 8. Issuance of Certificates:

(a) A certificate of registration as a Physical Therapist or Occupational Therapist as the case may be, shall be issued to any applicant who passes the respective examination upon payment of the required fees. The certificate shall show the full name of the registrant, indicating his name and the title of the occupation he is registered with. The same is to be signed by all the members of the Board of Examiners for Physical Therapists and Occupational Therapists and attested by the Secretary of the Board. The certificate shall have a serial number and must be duly authenticated by the seal of the Board.

- (a) Any Filipino physical therapist or occupational therapist holding a valid certificate of registration issued under the laws of a foreign country or state may be registered and practice his profession in the Philippines without . passing an examination given by the Board provided that the requirements for registration and licensing of the said profession in such foreign country or state are substantially the same as those provided for in R.A. No. 5680.
- (b) An alien registered as a Physical Therapist and Occupational Therapist in a foreign country or holding a valid certifi-cate as such under the laws of his country may be permitted to practice his profession in the Philippines without passing anymore an examination given by the Board of Examiners for Physical Therapists or Occupational Therapists in the Philippines provided that the requirements for examination and registration for this profession in his country are substantially the same as those provided for in R.A. No. 5680; and provided further, that the laws of such foreign country. or state grant the same privileges to Filipinos registered as Physical Therapists and Occupational Therapists in the Philippines on the same basis as the subjects or citizens of such foreign country or state. Provided furthermore, that such alien shall have previously established a continuous residence in the Philippines for a period of not less than t hree (3) years as required in R.A. No. 5181.

Sec. 10. The Board may, at its discretion, issue a certificate of registration as Physical Therapy Technician and/or Occupational Therapy Technician, to any person who possesses the following qualifications:

  - (3) He must be of legal age, and physically and mentally sound; and
  - (4) He must have at least 300 hours of working experience in an Occupational Therapy Clinic under the supervision of a registered Occupational Therapist;
  - (5) Notwithstanding (1) and (4) above, Occupational Therapy Technicians who qualified by unassembled examination given by the Civil Service Commission on June 30, 1969, may be registered by the Board.

Provided that all certificates issued by the Board under this Section may be suspended, revoked or reissued, in the manner prescribed for certificates of registration as physical therapist and/or occupational therapist. Any person who has been granted a certificate for purposes of compliance with the provisions of this Act, shall be considered as registered in the Board of Examiners for Physical Therapists and Occupational Therapists while said certificate remains valid and of good standing. Provided, finally, holders of certificates as Physical Therapist Technician and/or Occupational Therapist Technician shall confine their practice as technician within the limits of a hospital or institution of learning.

The fee for issuance of a certificate as Physical Therapy Technician and/or Occupational Therapy Technician is F30.00 and the annual registration fee is F2.00.

- (a) A complaint may be filed by any person or persons or firms or corporations through its authorized representatives against a registered physical therapist or occupational therapist for any of the grounds provided in the preceding section. The Board, however, may institute an administrative proceedings, motu propio against a registered physical therapist or occupational therapist for causes mentioned in the preceding Section and for any other valid causes for the purpose of upholding the integrity of the physical therapy and/or occupational therapy profession in the Philippines.
- (b) The complaint must be filed in three copies and must be under oath specifying therein clearly, and concisely the cause or causes of action against the respondent. Complaints received not in due form shall not be acted upon by the Board.

## (c) Service and Answer:

Upon receipt of the complaint and if the Board finds the same to be meritorious, the respondent shall be furnished a copy of said complaint and shall require him to submit his formal answer within ten (10) days after receipt thereof. The answer shall consist of either a specific denial or a general denial as the case may be, to the material allegations of the complaint. If after receipt of the complaint within the period afore-mentioned the respondent fails or does not submit his answer to the complaint, the Board may set the case for investigation. ## Sec. 13. Petition for Reconsideration:

(a) Petitions for reconsideration or petitions for rehearing shall be filed within thirty (30) days after receipt of the final order or judgment or decision of the Board, otherwise the same shall not be entertained anymore. Only one petition for reconsideration or for re-hearing shall be entertained by the Board.

# (b) Grounds for petition for reconsideration or for re-hearing:

The following shall be valid grounds for entertaining petitions for reconsideration or for re-hearing:

- (1) If the decision is not in conformity with the evidence and/or facts presented;
- (2) Newly discovered evidence which could not, with reasonable diligence, be discovered or produced during the hearing of the administrative case, and which, if presented will probably alter the result of the investigation.

# Sec. 14. Appeal from Judgment:

Within thirty (30) days from promulgation of all final judgments of the Board, either party to an administrative case may file directly his appeal to the Office of the President whose decision shall be final. The appellant shall notify the Board that he is appealing his case to the Office of the President and shall serve a copy of his appeal upon the adverse party or his attorney.
