RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HoPE) OF PROFESSIONAL REGULATION COMMISSION – LUCENA REGIONAL OFFICE FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE PROVISION OF SECURITY SERVICES 2019 TO VIVUS SECURITY AGENCY AND INVESTIGATION SERVICES, INC., WITH THE BID AMOUNT OF TWO MILLION EIGHT HUNDRED SEVENTY FIVE THOUSAND THREE HUNDRED ONE PESOS AND 28/100 ONLY (₱2,875,301.28)

WHEREAS, On February 18, 2019, the Regional Bids and Awards Committee (RBAC) caused the posting of the Invitation to Bid through public bidding for the Provision of Security Services 2019 in the Philippine Government Procurement System (PhilGEPS), PRC Website, and in conspicuous places within the premises of PRC Lucena Regional Office;

**WHEREAS,** On February 18 to March 11, 2019, selling period of bidding documents, only one (1) prospective bidder purchased the bidding documents (BDS);

WHEREAS, On March 11, 2019, the scheduled submission of bids, at exactly 9:00 AM, only VIVUS Security Agency and Investigation, Inc., a lone bidder submitted its bid containing their eligibility, technical and financial requirements;

WHEREAS, On March 11, 2019 at 10:00 AM, in compliance with Section 30 Rule IX of the Revised Implementing Rules and Regulations of Republic Act 9184, the RBAC conducted a preliminary examination of bids using a non-discretionary "pass / fail" criterion. The RBAC opened the bid documents of VIVUS Security Agency and Investigation, Inc. consisting of a bid price of TWO MILLION EIGHT HUNDRED SEVENTY FIVE THOUSAND THREE HUNDRED ONE PESOS AND 28/100 ONLY (₱2,875,301.28);

**WHEREAS,** On March 12, 2019, VIVUS Security Agency and Investigation, Inc. was subjected to post-qualification at 2<sup>nd</sup> Floor, 51 Raquel Building Zamora Street, Brgy.6, Lucena City to verify, validate and ascertain all the statement made, and documents submitted by the bidder during the submission and opening of bids in its Eligibility, Technical and Financial Envelopes including the additional documentary requirements that will be submitted by the said bidder during post-qualification;

**WHEREAS,** VIVUS Security Agency and Investigation, Inc., having passed the post qualification conducted by the RBAC, was declared as the Single Calculated and Responsive Bidder.

WHEREFORE, the Regional Bids and Awards Committee (RBAC) RESOLVES, as it hereby RESOLVED, to RECOMMEND to the Head of the Procuring Entity (HoPE) of PRC Lucena Regional Office the award to VIVUS SECURITY AGENCY AND INVESTIGATION, INC., the contract for the PROVISION OF SECURITY SERVICES 2019 with the bid amount of TWO MILLION EIGHT HUNDRED SEVENTY FIVE THOUSAND THREE HUNDRED ONE PESOS AND 28/100 ONLY (₱2,875,301.28 inclusive of VAT).
