Relative to this, all examinees of Davao City are required to bring the following:

- 1. Notice of Admission
- 2. One (1) piece metered-stamped window mailing envelope purchased from PHILPost
- 3. Two (2) or more pencils (No. 2)
- 4. Ball pens with **BLACK** ink only
- 5. One (1) piece long brown envelope
- 6. One (1) piece long transparent (non colored) plastic envelope (for keeping your valuables and other allowed items).
- 7. For pregnant examinee, submit clearance from the OB-Gynecologists
 - Clearance should indicate that the examinee is cleared to take the licensure examination.
 - ✤ No OB-Gyne Clearance, No Exam.
- 8. Bring food and water. It must be put in transparent containers.
 - Food deliveries are not allowed.

Schools, review center, co-examinees, or any other groups are not allowed to distribute food or drinks outside or inside the testing center premises, even during break time.

IMPORTANT REMINDERS

 - FEMALE: White blouse or shirt with collar (without any seal, logo or mark). Decent pants, slacks or skirts.

- 7. Avoid using Plastic PET Bottles, plastic wrappers and food packages. This is in observance with the eco-solid waste initiatives of our partner schools. Tumblers may be used but subject for inspection.
