GENERAL INSTRUCTIONS TO LEPT EXAMINEES

- 1. Check or verify your school/building assignments at the PRC official website (<u>www.prc.gov.ph</u>) or through the Notices/ Announcements to be posted at the PRC premises two (2) to three (3) working days before the date of examination.
- 2. On the day of the examination, report to the school/building assignment not later than 5:30 A.M. Be punctual. Late examinees will not be admitted.
- 3. Examinees are required to wear the following attire on examination day:
 - a. Male examinee Tucked-in white polo shirt with collar (without any seal, logo, or mark) Decent pants or slacks
 - b. Female examinees Tucked-in white blouse or shirt with collar (without any seal, logo, or mark) Decent pants or slacks
- 4. Examinees must be well-groomed, with hair properly clipped and/or pony tailed.

- 5. Bring the following on examination day:
 - a. Notice of Admission
 - b. Official Receipt of payment of application for examination
 - c. One (1) piece Long Transparent White Plastic Envelope (for keeping your valuables and other allowed items)
 - d. One (1) piece long size brown envelope
 - e. Two (2) or more Pencils (No. 2)
 - f. Ball pen with **black ink only**.
- 6. The following are **STRICTLY PROHIBITED** inside the examination premises/rooms:
 - a. Books, notes, review materials, and other materials containing coded data/ information/ formula;
 - b. For LEPT Elementary Level- ALL KINDS OF CALCULATOR For LEPT Secondary Level- ALL KINDS OF CALCULATOR EXCEPT FOR THOSE WITH MATHEMATICS MAJOR PURSUANT TO COMMISSION RESOLUTION NO. 1809-2024.

ONLY ONE CALCULATOR SHALL BE ALLOWED INSIDE THE EXAMINATION ROOM. ALL CALCULATORS SHALL BE INSPECTED AND HAVE TO BE RESET BEFORE THE START OF THE EXAMINATION.

- c. APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO STORE OR RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSES;
- d. Bags of any kind (ladies bags, shoulder bags, attache case, backpacks, etc.)
- e. Other examination aids not stated in this program.

The rules on the conduct of bodily search, inspection of personal belongings of the examinees, and the seizure/confiscation of prohibited items during the licensure exam (Annex A of PRC Memorandum Order No. 57, s. 2020) shall be strictly observed.

- 7. Examinees and examination personnel are encouraged to observe the minimum health standards per DOH Circular No. 0324 (s. 2023)¹ throughout the conduct of the examination.
- 8. Read carefully and follow the instructions on your **NOTICE OF ADMISSION** and **EXAMINEES GUIDE.**
- NOTE: PERSONAL BELONGINGS BROUGHT BY AN EXAMINEE SHALL BE FOR HIS/HER OWN ACCOUNT. THE PRC WILL NOT BE ANSWERABLE FOR ANY SUCH ITEM OR PERSONAL BELONGING THAT MIGHT BE LOST DURING THE EXAM WITHOUT FAULT OR NEGLIGENCE ON ITS PART.
