GENERAL INSTRUCTIONS TO LEPT EXAMINEES

1. Check or verify your school/building assignments at the PRC official website ([www.prc.gov.ph](http://www.prc.gov.ph)) or through the Notices/ Announcements to be posted at the PRC premises two (2) to three (3) working days before the date of examination.
2. On the day of the examination, report to the school/building assignment not later than 5:30 A.M. Be punctual. **Late examinees will not be admitted.**
3. Examinees are required to wear the following attire on examination day:
  - a. Male examinee - Tucked-in white polo shirt with collar (without any seal, logo, or mark) Decent pants or slacks
  - b. Female examinees - Tucked-in white blouse or shirt with collar (without any seal, logo, or mark) Decent pants or slacks
4. Examinees must be well-groomed, with hair properly clipped and/or pony tailed.

5. Bring the following on examination day:
  - a. Notice of Admission
  - b. Official Receipt of payment of application for examination
  - c. One (1) piece Long Transparent White Plastic Envelope (for keeping your valuables and other allowed items)
  - d. One (1) piece long size brown envelope
  - e. Two (2) or more Pencils (No. 2)
  - f. Ball pen with **black ink only**.
6. The following are **STRICTLY PROHIBITED** inside the examination premises/rooms:
  - a. Books, notes, review materials, and other materials containing coded data/ information/ formula;
  - b. **For LEPT Elementary Level- ALL KINDS OF CALCULATOR**  
**For LEPT Secondary Level- ALL KINDS OF CALCULATOR EXCEPT FOR THOSE WITH MATHEMATICS MAJOR PURSUANT TO COMMISSION RESOLUTION NO. 1809-2024.**  
  
**ONLY ONE CALCULATOR SHALL BE ALLOWED INSIDE THE EXAMINATION ROOM. ALL CALCULATORS SHALL BE INSPECTED AND HAVE TO BE RESET BEFORE THE START OF THE EXAMINATION.**
  - c. **APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO STORE OR RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSES;**
  - d. Bags of any kind (ladies bags, shoulder bags, attache case, backpacks, etc.)
  - e. Other examination aids not stated in this program.

The rules on the conduct of bodily search, inspection of personal belongings of the examinees, and the seizure/confiscation of prohibited items during the licensure exam (Annex A of PRC Memorandum Order No. 57, s. 2020) shall be strictly observed.

7. Examinees and examination personnel are encouraged to observe the minimum health standards per DOH Circular No. 0324 (s. 2023)<sup>1</sup> throughout the conduct of the examination.
8. Read carefully and follow the instructions on your **NOTICE OF ADMISSION** and **EXAMINEES GUIDE**.

**NOTE: PERSONAL BELONGINGS BROUGHT BY AN EXAMINEE SHALL BE FOR HIS/HER OWN ACCOUNT. THE PRC WILL NOT BE ANSWERABLE FOR ANY SUCH ITEM OR PERSONAL BELONGING THAT MIGHT BE LOST DURING THE EXAM WITHOUT FAULT OR NEGLIGENCE ON ITS PART.**

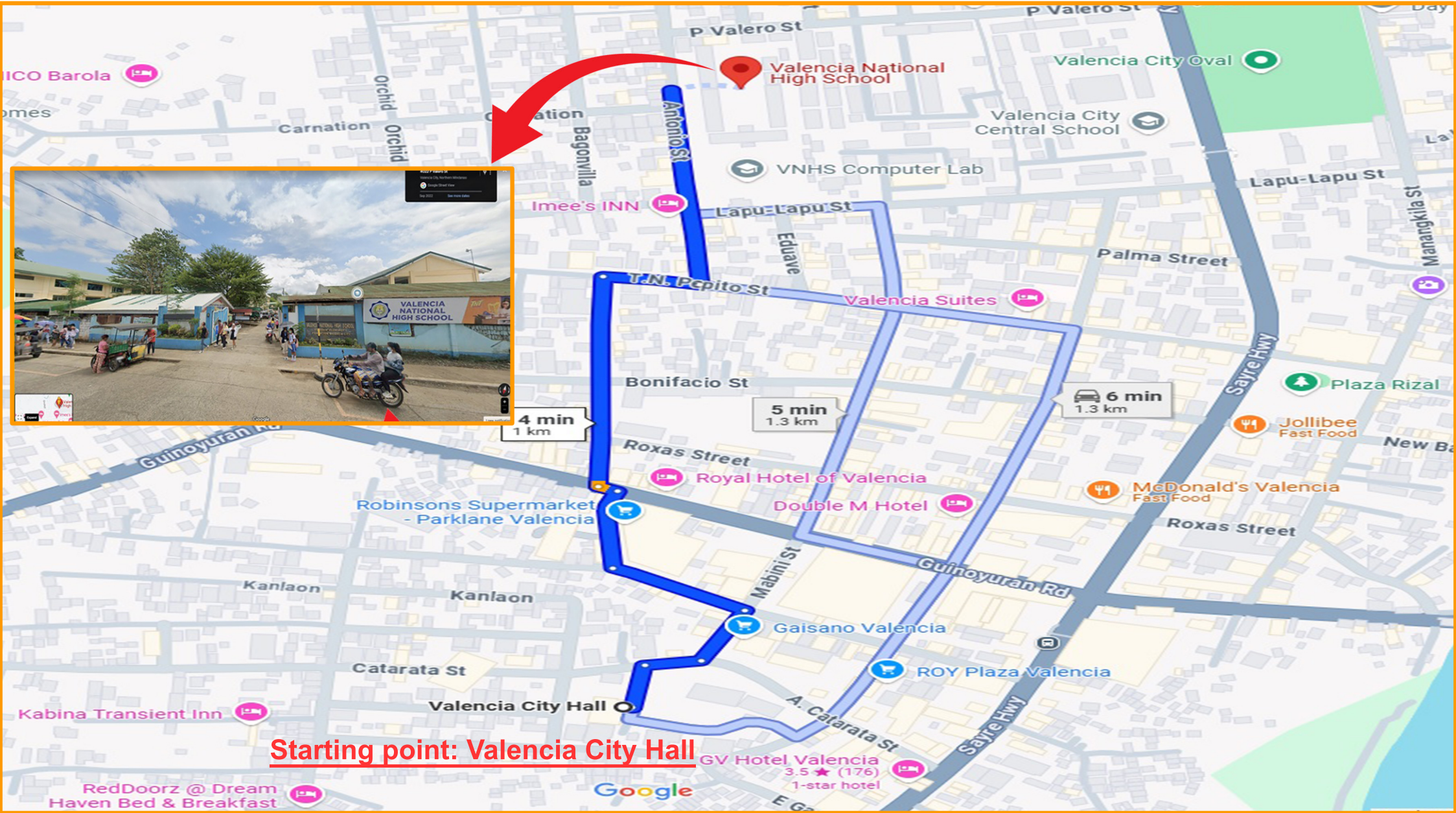
