Relative to this, all examinees of Davao City are required to bring the following:

- 1. Notice of Admission
- 2. Two (2) or more pencils (No. 2)
- 3. Ball pens with **BLACK ink only**
- 4. One (1) piece long size brown envelope
- 5. One (1) piece long transparent/plastic envelope (for keeping your valuables and other allowed items)
- 6. For pregnant examinee, submit clearance from the OB-Gynecologists
 - **Clearance should indicate that the examinee is cleared to take the licensure examination.**
 - *No OB-Gyne Clearance, No Exam.
- 7. Snacks and lunch packed in transparent containers.
 - ***Food deliveries are not allowed.**
 - **Schools, review center, co-examinees, or any other groups are not allowed to distribute food or drinks outside or inside the testing center premises, even during break time.**





















IMPORTANT REMINDERS

- 1. Examinees are prohibited to use CALCULATORS which are programmable or with embedded functions especially CASIO FX991ES and CASIO FX-991ES plus, cellular phone, ear plugs, bluetooth, and other electronic gadgets/devices. Examinees will be required to TURN OFF their mobile phone/s before entering the examination venue. Phone/s must be placed inside their bags and can only be used again upon exiting the venue;
- 2. Books, notes, review materials, and other printed materials containing coded data/information/formula are not allowed inside the testing center premises. Bringing of the said items inside the examination venue will be considered as CHEATING or an ACT OF DISHONESTY. If an examinee is found guilty, his/her examination papers shall be cancelled and shall either be suspended or debarred from taking future examinations.
- 3. Avoid using Plastic PET Bottles, plastic wrappers and food packages. This is in observance with the eco-solid waste initiatives of our partner schools.
- 4. Personal belongings brought by an examinee shall be for his/her own account. The PRC will not be answerable for any such item or personal belonging that might be lost during the examination without fault or negligence on its part.











GENERAL INSTRUCTIONS:

- 1. Check or verify your school/building assignments at the PRC official website (www.prc.gov.ph) or through the Notices/Announcements to be posted at the PRC premises two (2) to three (3) working days before the examination. Bring your NOTICE OF ADMISSION when you verify your school/building assignment. Visit your school/building assignment prior to the day of the examination.
- 2. Report to the school/building assignment before 5:30 a.m. on the first day of examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.
- 3. Examinees are required to wear their school uniforms.
- 4. Bring the following on examination day:
 - a. Notice of Admission
 - b. Official Receipt
 - c. Two (2) or more pencils (No. 2)
 - d. Ball pens with **BLACK ink only**
 - e. One (1) piece long brown envelope
 - f. One (1) piece long transparent/plastic envelope (for keeping your valuables and other allowed items)
- 5. The following are **PROHIBITED** inside the examination premises/rooms.
 - a. Books, notes, review materials, and other printed materials containing coded data/information/formula
 - b. CALCULATORS which are programmable or with embedded functions especially CASIO FX991ES and CASIO FX-991ES plus

- c. APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSES.
- d. Bags of any kind (ladies bag, shoulder bags, attaché case, backpacks, etc)
- e. Other examination aides not stated in this program.

All personal belongings of the examinees shall be surrendered to the proctor and shall be placed in a secured space within the examination room.

The rules on the conduct of bodily search, inspection of personal belongings of the examinees, and the seizure/confiscation of prohibited items during the licensure exam (Annex A of PRC Memorandum Order No. 57, s. 2020) shall be strictly observed.

- 6. Examinees and examination personnel are encouraged to observe the minimum health standards per DOH Circular No. 0324 (s. 2023)¹ throughout the conduct of the examination
- 7. Read carefully and follow the instructions on your **NOTICE OF ADMISSION** and **EXAMINEES GUIDE**.
