Pursuant to the PRC-DOH-PNP Administrative Order No. 01 dated July 28, 2021, examinees for the licensure examinations are required to submit either (1) a negative RTPCR Test Results, if falling under the groups stated in DOH Memorandum 2020-258A, or (2) a Certification issued by any government or private physician or barangay officer attesting that the examinee had undergone 14-day quarantine prior to the examination, or (3) copy of the Complete Vaccination Card.

Failure to present either of the three health safety documentary requirements, shall prohibit the examinee to enter the examination premises and to take the licensure examinations.
