

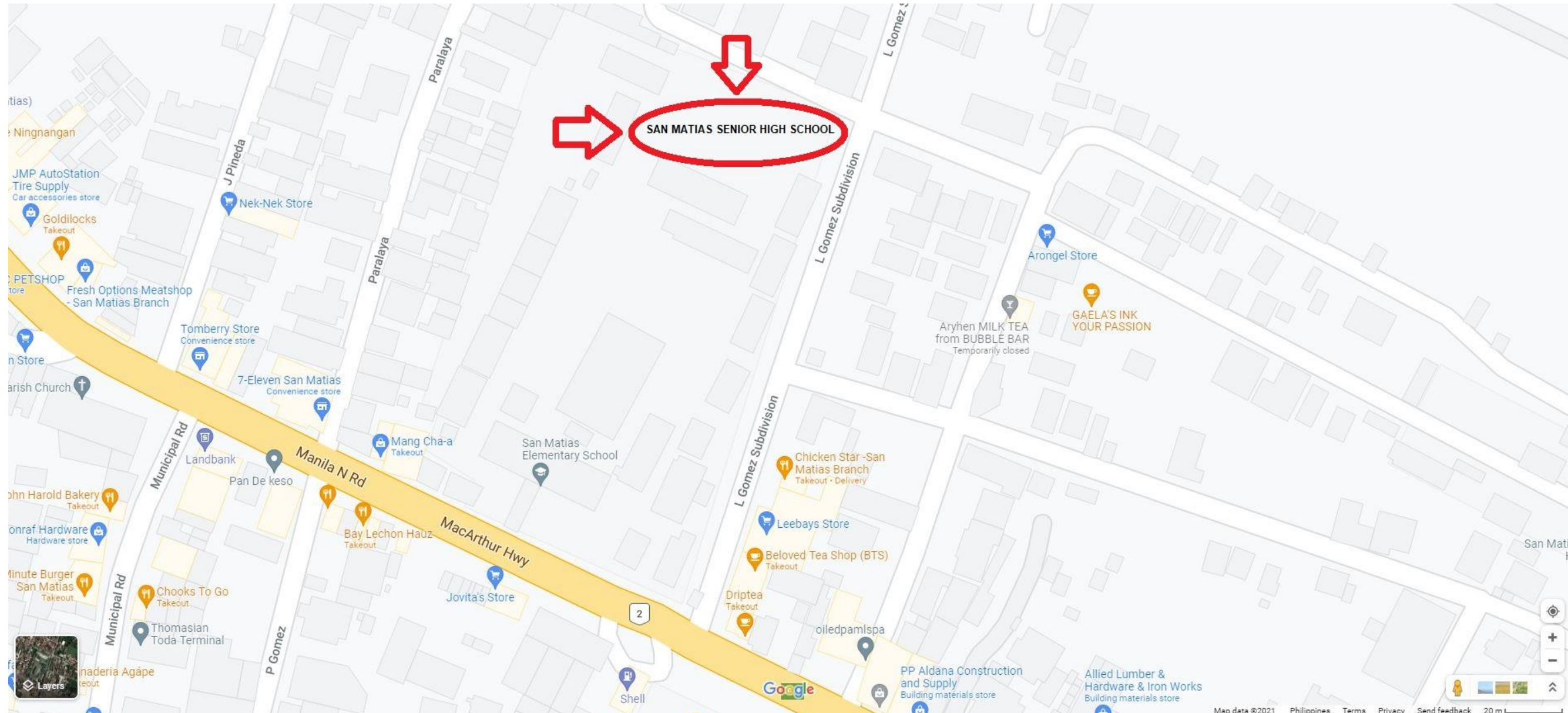


PROFESSIONAL REGULATION COMMISSION

PROFESSIONAL TEACHER – SECONDARY
SEPTEMBER 26, 2021

As per the City and Municipal Health Offices of the Local Government Units where the examinations will be held and in accordance to PRC Memorandum 68, examinees coming from places outside Pampanga are required to present negative RT-PCR test results on the day of the examination. Residents of Pampanga, on the contrary, are required to present either a 14-day quarantine certificate (from September 10-24 2021), duly signed by the RHU physician, with a dry seal, or negative RT-PCR test results.

These requirements are *mandatory* and failure to present either of the two, the examinee shall not be allowed to take the licensure examinations.
