REMINDER: USE SAME NAME IN ALL EXAMINATION FORMS. IF THERE IS AN ERROR IN SPELLING AND OTHER DATA KINDLY REQUEST YOUR ROOM WATCHERS TO CORRECT IT ON THE FIRST DAY OF EXAMINATION. REPORT TO YOUR ROOM ON OR BEFORE 6:30 A.M. LATE EXAMINEES WILL NOT BE ADMITTED.

- Pursuant to PRC-DOH-DILG-PNP Joint Administrative Order No. 2022-01, examinees are required to submit **EITHER** of the following on the examination day:
 - ✓ Negative RT-PCR Test Result.
 - ✓ Copy of the Full Vaccination Card (one or two doses depending on the vaccine received plus **BOOSTER**).
- These requirements are mandatory and failure to present **EITHER OF THE TWO**, the examinee shall **NOT** be allowed to take the licensure examination.
- If the examinee recently contracted COVID-19, a Certificate of Completion of Isolation or its equivalent signed by any of the following must be submitted:
 - ✓ Duly licensed Physician (government or private physician);
 - ✓ Municipal Health Officer, Provincial Health Officer or City Health Officer; and
 - ✓ Designated Barangay Health Worker Emergency Response Team (BHERTs) Officer or Barangay Health Worker visiting the residence of the examinee.
- Examinees coming from other countries are required to quarantine following the latest quarantine and isolation protocols and guidelines, in and around the time of examination.
- In addition to the abovementioned requirements, per PRC Memorandum Order No. 24 (s 2020), the following precautionary measures and protocols shall be observed and implemented during the conduct of licensure examination such as, but not limited to:
 - ✚ All examinees shall **NOT** be allowed to go outside the examination room during breaktime and lunchtime. Everyone must **bring their own packed lunch and snacks** to be placed under their seats and to be taken out only during breaktime.
- The examinees are required to inform the PRC Region I through email (ro1.examination@prc.gov.ph) or call (0942 631 5636), if they are showing any flu-like symptoms such as fever, cough and/or colds at least a day before the examination day. They shall be advised to defer taking the licensure examination but shall be allowed to take the next scheduled licensure examination without forfeiture of their payments.
- Examinees are **PROHIBITED** to **BRING** cellular phones inside the examination premises and to open/read books, notes, review and other printed materials containing coded data/information/formula for the **entire** examination period, **even during breaktime**.
- The following are **STRICTLY PROHIBITED** inside the examination premises/rooms for the **entire** examination period, **even during breaktime**:
 - a. Books, notes, review materials, and other printed materials containing coded data/information/formula.
 - b. Calculators which are programmable.
 - c. CASIO FX991ES and CASIO FX-991ES plus pursuant to Memorandum Circular No. 2018-01;
 - d. APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH AND ANY OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO STORE OR RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSE
 - e. Bags of any kind (ladies bag, shoulder bags, attaché case, backpacks, etc)
 - f. Other examination aides not stated in this program
