ROOM ASSIGNMENT AND REMINDER

1. Report at the examination venue before 5:30 AM on the first day of the examination. Late examinees will not be admitted;
2. Wear the prescribed attire as per examination program (see link below for the copy of program);
3. Bring your food and drinks for the entire day and necessary medications, including hygiene and sanitary kits in a TRANSPARENT/CLEAR containers/cellophanes. No examinee shall be allowed to leave the examination room during conduct of the examination except for restroom necessities;
4. Bring your Notice of Admission (NOA);
5. Use only the prescribed calculator, if applicable;
6. Bringing devices into the examination venue that can send messages, communicate, or take photos—such as cellphones, smartwatches, cameras, and similar gadgets—is strictly prohibited.
7. Review materials and other prohibited printed items are not allowed in the testing center premises;
8. Bags of any kind (ladies' bag, shoulder bag, attaché case, backpacks, etc.) are PROHIBITED. Please use a TRANSPARENT PLASTIC ENVELOPE to hold all items you'll be bringing to the exam, such as your NOA, valid ID, and other allowed materials;
9. Do not entertain impostors and fixers asking for money in exchange for favorable exam results;
10. Abide by the instructions provided by the room watchers and floor supervisors;

Non-compliance to any of the said protocols shall be dealt with accordingly.
