RESOLUTION No. 2020-32 Series of 2020

RECOMMENDING TO THE OIC – REGIONAL DIRECTOR OF THE PROFESSIONAL REGULATION COMMISSION (PRC) TACLOBAN REGIONAL OFFICE AS HEAD OF PROCURING ENTITY (HOPE), FOR HIS APPROVAL, THE AWARD OF THE CONTRACT FOR THE PROVISION OF SECURITY SERVICES 2020 TO TCO SECURITY AGENCY WITH THE BID AMOUNT OF EIGHT HUNDRED SEVENTY-FOUR THOUSAND FOUR HUNDRED FIFTEEN PESOS AND SIXTY-ONE CENTAVOS (P874,415.61)

WHEREAS, on May 21, 2020, the Regional Bids and Awards Committee (RBAC) posted the Invitation to Bid through Public Bidding for the Procurement of Security Services, with an Approved Budget for the Contract (ABC) in the amount of **ONE MILLION THREE HUNDRED NINETY-SIX THOUSAND FIVE PESOS AND SIXTY-THREE CENTAVOS (P1,396,005.63)**, in the websites of the Professional Regulation Commission (PRC) and the Philippine Government Electronic Procurement System (PhilGEPS), and in conspicuous places at the premises of PRC Tacloban City Regional Office;

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, representatives from the Commission on Audit (COA), as well as observers from the private sectors, namely the Filipino-Chinese Chamber of Commerce and the Volunteers Against Crime and Corruption (VACC), were invited to observe and witness the conduct of the Pre-Bid Conference, Opening of Bids and Post-Qualification;

WHEREAS, in response to the Invitation to Bid, two (2) prospective bidders, Vision Security Services, Inc. and TCO Security Agency, signified their intention to participate in public bidding;

WHEREAS, a Pre-Bid Conference was held on May 28, 2020 at 10:00 a.m. at the Office of the Regional Director to allow the RBAC to clarify and/or explain any of the requirements, terms, conditions, and specifications stipulated in the Bidding Documents. During the said activity, representatives from TCO Security Agency and Vision Security Services, Inc. were present;

WHEREAS, as of June 10, 2020 at 10:00 AM, the scheduled deadline for the Submission and Receipt of Bids, two (2) bidders, namely, Vision Security Services, Inc. and TCO Security Agency, have submitted their respective official bids containing their eligibility, technical, and financial requirements;

WHEREAS, during the Opening and Evaluation of Bids immediately following the deadline on June 10, 2020, both aforementioned bidders passed the preliminary examination of its respective eligibility and technical requirements as conducted by the RBAC using a non-discretionary "pass/fail" criterion;

WHEREAS, the RBAC subsequently opened the financial bid proposals of both bidders. TCO Security Agency submitted a bid price of **EIGHT HUNDRED SEVENTY-FOUR THOUSAND FOUR HUNDRED FIFTEEN PESOS AND SIXTY-ONE CENTAVOS (P874,415.61)**, VAT inclusive and within the ABC,

while Vision Security Services, Inc. submitted a bid price of **EIGHT HUNDRED NINETY-THREE THOUSAND SEVENTY-SIX PESOS AND THIRTY-SIX CENTAVOS (P893,076.36)**, VAT inclusive and within the ABC;

WHEREAS, TCO Security Agency was found to be the bidder with the Lowest Calculated Bid (LCB), and was subjected to post-qualification on June 18, 2020 at their office premises, located at 116 Avenida Veteranos Avenue, Tacloban City, to verify, validate and ascertain all statements made and documents submitted including their submission of post qualification documents;

WHEREAS, TCO Security Agency, having passed the post-qualification process, was declared as the bidder with the Lowest Calculated and Responsive Bid (LCRB);

WHEREFORE, the Regional BAC **RESOLVES**, as it is hereby **RESOLVED**, to **RECOMMEND** to the OIC – Regional Director of the Professional Regulation Commission Tacloban Regional Office as Head of Procuring Entity (HOPE), for his approval, the award of the contract for the Provision of Security Services 2020, to **TCO SECURITY AGENCY**, with the bid amount of **EIGHT HUNDRED SEVENTY-FOUR THOUSAND FOUR HUNDRED FIFTEEN PESOS AND SIXTY-ONE CENTAVOS (P874,415.61)**.
