WHEREAS, during the opening and evaluation of bids SMP General Merchandise passed the preliminary examination of its eligibility and technical requirements using a non-discretionary "pass/fail" criterion, thus its financial bid proposal was opened and its bid is TWO HUNDRED THIRTY-EIGHT THOUSAND THREE HUNDRED PESOS ONLY (Php238,300.00) and was declared to be the Single Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Head of the Procuring Entity of PRC Pagadian Regional Office for her approval the award of the contract for the PROCUREMENT FOR THE STEEL CABINETS, STEEL RACKS, GANG CHAIRS, MONEY COUNTER, VOICE RECORDER AND COUNTERFEIT DETECTOR FOR PRC PAGADIAN REGIONAL OFFICE IX with bid amount of TWO HUNDRED THIRTY-EIGHT THOUSAND THREE HUNDRED PESOS ONLY (Php238,300.00)
