Resolution No. ILO-2022-01

RECOMMENDING TO THE HEAD OF PROCURING ENTITY OF THE PROFESSIONAL REGULATION COMMISSION ILOILO REGIONAL OFFICE, FOR HIS APPROVAL, THE AWARD OF THE CONTRACT TO BLUEWARRIORS SECURITY AGENCY (BWSA) AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROVISION OF SECURITY SERVICES FOR PRC ILOILO REGIONAL OFFICE AND OFFSITE SERVICE CENTER – ROBINSONS BACOLOD FOR ONE (1) YEAR

WHEREAS, the INVITATION TO BID was posted at the PhilGEPS, PRC official website, and the premises of the PRC Iloilo Regional Office on September 10, 2021 for the Provision of Security Services for one (1) year for PRC Iloilo Regional Office and Offsite Service Center – Robinsons Bacolod with approved budget for the contract in the amount of **ONE MILLION THIRTY-NINE THOUSAND PESOS (Php1,039,000.00)**, inclusive of VAT and all applicable taxes and fees.

WHEREAS, pursuant to Section 22, Rule VII of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184), known as the Government Procurement Reform Act, a **PRE-BID CONFERENCE** was conducted on 17 September 2021 via videoconferencing to discuss and explain the different aspects of the project as well as to accommodate any inquiries or clarifications from the prospective bidders. During which, three (3) prospective bidders attended the said Pre-Bid Conference namely: Bluewarriors Security Agency, Globe Security Services Corporation, and Gran Royal Security & Investigation Agency, Inc.;

WHEREAS, on 25 September 2021, Bid Bulletin No. 1 was posted to PhilGEPS, PRC official website, and the premises of the PRC Iloilo Regional Office to address the clarifications raised by the prospective bidders from the Bidding Documents during Pre-Bid Conference;

WHEREAS, during the deadline for the submission and opening of bids on 29 September 2021, only BLUEWARRIORS SECURITY AGENCY (BWSA) purchased the bidding documents and submitted their bid;

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a no-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered "failed".

WHEREAS, after the preliminary examination, the RBAC declared BLUEWARRIORS SECURITY AGENCY as "PASSED" for having submitted the complete eligibility and technical requirements. Thereafter, the financial bid was opened with the bid price of **EIGHT HUNDRED THIRTY-TWO THOUSAND SEVENTY PESOS AND 40/100 (Php832,070.40)**;

WHEREAS, the RBAC after detailed and thorough bid evaluation and careful examination of bidding documents determined that BLUEWARRIORS SECURITY AGENCY is responsive and compliant to all requirements and conditions of the project;

WHEREAS, on 12 November 2021, pursuant to Section 34 Rule X of the Revised IRR of RA 9184, a **POST-QUALIFICATION** was conducted to BLUEWARRIORS SECURITY AGENCY to ascertain the authenticity and validity of their eligibility and technical documents submitted during the opening of bid proposal;

WHEREAS, BLUEWARRIORS SECURITY AGENCY having passed the post-qualification evaluation, was declared to be the Single Calculated and Responsive Bidder;

WHEREFORE, in view of the foregoing premises, the **REGIONAL BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to **RECOMMEND** to the Head of Procuring Entity of PRC Iloilo Regional Office, for his approval, the award of the Contract to **BLUEWARRIORS SECURITY AGENCY** for the Provision of Security Services for PRC Iloilo Regional Office and Offsite Service Center – Robinsons Bacolod with the amount of **EIGHT HUNDRED THIRTY-TWO THOUSAND SEVENTY PESOS AND 40/100 (Php832,070.40) annually**, or **SIXTY-NINE THOUSAND THREE HUNDRED THIRTY-NINE PESOS AND 20/100 (Php69,339.20) monthly**, inclusive of VAT and all applicable taxes and fees.




