RECOMMENDING TO THE OIC – REGIONAL DIRECTOR OF THE PROFESSIONAL REGULATION COMMISSION (PRC) TACLOBAN REGIONAL OFFICE AS HEAD OF PROCURING ENTITY (HOPE), FOR HIS APPROVAL, THE AWARD OF THE CONTRACT FOR THE PROVISION OF SECURITY SERVICES 2019 TO VISION SECURITY SERVICES, INC. WITH THE BID AMOUNT OF SEVEN HUNDRED SEVEN THOUSAND NINE HUNDRED THIRTY-TWO PESOS AND FORTY-FOUR CENTAVOS (\$\mathbb{P}707,932.44)

WHEREAS, on April 3, 2019, the Regional Bids and Awards Committee (RBAC) posted the Invitation to Bid through Public Bidding for the Procurement of Security Services, with an Approved Budget for the Contract (ABC) in the amount of SEVEN HUNDRED FORTY-SEVEN THOUSAND ELEVEN PESOS AND FORTY CENTAVOS (P747,011.40), in the websites of the Professional Regulation Commission (PRC), the Philippine Government Electronic Procurement System (PhilGEPS), and in conspicuous places at the premises of PRC Tacloban City Regional Office;

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, representatives from the Commission on Audit (COA), as well as observers from the private sectors, namely the Filipino-Chinese Chamber of Commerce and the Volunteers Against Crime and Corruption (VACC), were invited to observe and witness the conduct of the Opening of Bids and Post-Qualification as scheduled;

WHEREAS, in response to the Invitation to Bid, four (4) prospective bidders signified their intention to participate in public bidding, to wit: Vision Security Services, Inc.; Cafe Security and Investigation Agency, Inc.; TCO Security Agency; and Metroglobal Security Agency, Inc.;

WHEREAS, Bid Bulletin No. 1 dated April 12, 2019 and Bid Bulletin Nos. 2 and 3 dated April 15, 2019, were issued to amend specific provisions in and parts of the Bidding Documents for this project;

WHEREAS, as of April 23, 2019 at 9:00 AM, the scheduled deadline for the Submission and Receipt of Bids, two (2) bidders, namely, Vision Security Services, Inc. and TCO Security Agency, have submitted their respective official bids containing their eligibility, technical, and financial requirements;

**WHEREAS**, during the Opening and Evaluation of Bids on April 23, 2019 at 10:00 AM, both aforementioned bidders passed the preliminary examination of its respective eligibility and technical requirements as conducted by the RBAC using a non-discretionary "pass/fail" criterion;

WHEREAS, the RBAC subsequently opened the financial bid proposals of both bidders. Vision Security Services, Inc. submitted a bid price of SEVEN HUNDRED SEVEN THOUSAND NINE HUNDRED THIRTY-TWO PESOS AND FORTY-FOUR CENTAVOS (\$\frac{1}{2}\$707,932.44), VAT inclusive and within the ABC, while TCO Security Agency submitted a bid price of SEVEN HUNDRED FORTY-
