DECLARATION OF FAILURE OF BIDDING FOR THE PROVISION OF SECURITY SERVICES (2020) FOR PRC TACLOBAN CITY REGIONAL OFFICE WITH THE APPROVED BUDGET FOR THE CONTRACT (ABC) OF ONE MILLION FOUR HUNDRED FIFTY-EIGHT THOUSAND PESOS ONLY (Php1,458,000.00) FOR FY 2020

WHEREAS, on February 27, 2020, an Invitation to Bid was duly posted in the PhilGEPS, PRC's official website and in conspicuous places within the PRC regional office premises for the provision of Security Services (2020) for PRC Tacloban City Regional Office, with an approved budget for the contract (ABC) in the amount of ONE MILLION FOUR HUNDRED FIFTY-EIGHT THOUSAND PESOS (\$\Pi\$1,458,000.00);

WHEREAS, in compliance with the pertinent provisions of the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, representatives from the Commission on Audit (COA), as well as observers from the private sectors, namely the Filipino-Chinese Chamber of Commerce and the Volunteers Against Crime and Corruption (VACC), were invited to observe and witness the conduct of the Opening of Bids and Post-Qualification as scheduled;

WHEREAS, as stated in the Bidding Documents, the Pre-Bid Conference is scheduled on March 5, 2020 at 10:00 a.m. while the deadline for the submission of bids and the opening & evaluation of bids are scheduled on March 18, 2020 at 10:00 a.m.;

**WHEREAS**, a Pre-Bid Conference was held on the scheduled date and time by the Regional Bids & Awards Committee (RBAC) to provide clarifications to the requirements in the submission of bids. Two prospective bidders, namely TCO Security Agency and Vision Security Services, Inc., participated in the conference;

WHEREAS, during the opening and evaluation of bids on March 18, 2020 at 10:00 a.m., it was found that two bidders, namely TCO Security Agency and Vision Security Services, Inc., submitted their respective bids for this procurement;

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act, requires that the preliminary examination of bids be conducted by merely checking the presence or absence of documentary requirements using a non-discretionary "pass / fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered "failed";

WHEREAS, upon initial evaluation of the documents submitted by the bidders, it was found that both bidders failed to submit their respective copies of Acknowledgment and Compliance to the General Conditions and Special Conditions of the Contract, which is essentially required in the bidding documents of this procurement;

WHEREAS, Section 35, Rule X of the IRR provides for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with the bid requirements as prescribed, to wit:

## Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a.) No bids are received;
- b.) All prospective bidders are declared ineligible;
- c.) All bids fail to comply with all the bid requirements or post-qualification, or XXXX

NOW THEREFORE, in view of the above premises, the Regional BAC RESOLVES, as it is hereby RESOLVED to DECLARE A FAILURE OF BIDDING FOR THE PROVISION OF SECURITY SERVICES (2020) FOR PRC TACLOBAN CITY REGIONAL OFFICE WITH THE APPROVED BUDGET FOR THE CONTRACT (ABC) OF ONE MILLION FOUR HUNDRED FIFTY-EIGHT THOUSAND PESOS ONLY (Php1,458,000.00) FOR FY 2020. Consequently, the RBAC shall conduct a re-bidding of the said procurement project.
