## **BIDS AND AWARDS COMMITTEE**

Resolution No. 2022- 116(A)

RECOMMENDING FOR THE APPROVAL OF THE CHAIRPERSON OF THE PROFESSIONAL REGULATION COMMISSION, THE PROCUREMENT OF ADDITIONAL VIDEO CONFERENCING EQUIPMENT TO AVID SALES CORPORATION, THROUGH ALTERNATIVE METHOD OF PROCUREMENT UNDER SECTION 51 (REPEAT ORDER), IN COMPLIANCE WITH THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

WHEREAS, on 04 July 2022, as a result of a public bidding, the Commission entered into a contract with AVID SALES CORPORATION (ASC) for the supply and delivery of Video Conferencing equipment, with the contract price of One Million One Hundred Seventy Thousand Pesos (Php1,170,000.00) or Seventy-Eight Thousand Pesos (Php78,000.00) per unit;

WHEREAS, the Network Infrastructure and Information Security Division (NIISD) submitted a request for a repeat order of additional three (3) units of Video Conferencing Equipment to be distributed to the Regional Offices that requested for said equipment;

WHEREAS, Section 51 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, provides:

## "Section 51. Repeat Order

Repeat Order, when provided for in the APP, is a method of procurement of goods from the previous winning bidder, whenever there is a need to replenish goods procured under a contract previously awarded through Competitive Bidding. Repeat orders shall likewise be subject to the following conditions:

- a) Unit prices of the repeat order must be the same as or lower than those in the original contract, provided that such prices are still the most advantageous to the GOP after price verification;
- b) The repeat order will not result in splitting of contracts, requisitions, or purchase orders, as provided for in Section 54.1 of this IRR;
- c) Except in cases duly approved by the GPPB, the repeat order shall be availed of only within six (6) months from the date of the Notice to Proceed arising from the original contract: Provided, That there has been a partial delivery, inspection and acceptance of the goods within the same 6-month period; and
- d) Repeat orders shall not exceed twenty-five percent (25%) of the quantity of each item in the original contract. In order not to exceed the 25% threshold, the goods under the original contract must be:
  - i. Quantifiable
  - ii. Divisible; and
  - iii. Consisting of at least four (4) units per item.

WHEREAS, on October 20, 2022, the Bids and Awards Committee (BAC) met and evaluated the submitted documents of the NIISD to support the said request;

**WHEREAS**, the unit price offered by ASC is the same as stated in the original contract or Seventy-Eight Thousand Pesos (Php78,000.00) per unit;

WHEREAS, as the result of the recently conducted market the price verification by the NIISD, they find that the price offered by ASC is still the most advantageous to the government;

**WHEREAS**, the repeat order will not result in splitting of contracts, requisitions, or purchase orders, as provided for in Section 54.1 of the same IRR of RA No. 9184;

WHEREAS, the repeat order is availed of within six (6) months from the effectivity date of the original contract on 11 July 2022, as stated in the Notice to Proceed;

WHEREAS, the repeat order shall only cover three (3) units which does not exceed twenty-five percent (25%) of the quantity of Video Conferencing Equipment in the original contract;

WHEREAS, ASC has successfully delivered and complied with the terms and conditions of the original contract with the Commission;

WHEREAS, Video Conferencing Equipment is necessary to Regional Offices during the conduct of virtual/online activities of the Commission;

WHEREAS, after the evaluation conducted, the BAC determines the compliance of the NIISD for the Repeat Order modality for the procurement of additional Video Conferencing Equipment with ASC;

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend for approval of the Chairperson of the Professional Regulation Commission, the procurement of additional Three (3) units of VIDEO CONFERENCING EQUIPMENT to AVID SALES CORPORATION at Seventy-Eight Thousand Pesos (Php78,000.00) per unit or the total amount of Two Hundred Thirty-Four Thousand Pesos (Php234,000.00), through Alternative Method of Procurement under Section 51 (REPEAT ORDER), in compliance with the 2016 Revised IRR of RA No. 9184.
