### PROCUREMENT OF ADDITIONAL THREE (3) UNITS OF VIDEO CONFERENCING EQUIPMENT THROUGH ALTERNATIVE MODE OF PROCUREMENT UNDER SECTION 51 (REPEAT ORDER)

CS-11-2022-83 dated NOV 16 2022
