RESOLUTION RECOMMENDING TO THE HEAD OF PROCURING ENTITY (HOPE) OF THE PROFESSIONAL REGULATION COMMISSION (PRC) REGIONAL OFFICE XI THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF RT-PCR TEST SERVICE OF PRC-RO XI EXAMINATION PERSONNEL FOR THE CONDUCT OF VARIOUS LICENSURE EXAMINATIONS FOR JULY WITH AN APPROVED BUDGET FOR THE CONTRACT (ABC) OF ONE HUNDRED TWENTY-TWO THOUSAND PESOS (PHP122,000.00) THROUGH SMALL VALUE PROCUREMENT SECTION 53.9 OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

WHEREAS, a revised Purchase Request No. 2022-06-0220 dated 03 June 2022, was received by PRC XI Regional Bids and Awards Committee (RBAC) secretariat on 08 June 2022, for the Procurement of RT-PCR Test Service for July 2022 for PRC - RO XI Examination Personnel for the conduct of various Board Examinations, with an ABC of PhP122,000.00;

WHEREAS, Request for Quotation (RFQ) No. 2022-06-072 dated 10 June 2022 was posted and published in PhilGEPS website, Procuring entity website and in a conspicuous place within the premises of PRC RO XI in compliance with Republic Act No. 9184 otherwise known as the "Philippine Government Procurement Reform Act," and its 2016 Revised Implementing Rules and Regulations and sent to prospective bidders/suppliers, namely: VITALAB REDMARK CORPORATION, DAVAO ONE WORLD DIAGNOSTIC CENTER, INC., and SAFEGUARD DNA DIAGNOSTICS INC.;

WHEREAS, there were two possible bidders who viewed the opportunity in the PhilGEPS website namely: GERARD TRADING & SLURRY ASPHALT TRADING but none of them submitted their quotations;

WHEREAS, in response to the RFQs, the following suppliers submitted their quotations within the deadline, namely: VITALAB REDMARK CORP., and DAVAO ONE WORLD DIAGNOSTIC CENTER, INC.;

WHEREAS, during the evaluation of bids and eligibility requirements on 16 June at 4:00 p.m., the Regional Bids and Awards Committee found and declared DAVAO ONE WORLD DIAGNOSTIC CENTER, INC., as the Single Calculated and Responsive Bidder with the bid amount of Php120,780.00;

WHEREAS, VITALAB REDMARK CORP. was disqualified for non-submission of the documentary eligibility requirements (SEC/DTI Registration, and Proof that the Testing Laboratory is Licensed COVID 19 Testing Laboratory in the Philippines)

WHEREAS, based on the Abstract of Quotations, it is recommended that the award be made to DAVAO ONE WORLD DIAGNOSTIC CENTER, INC., as the Single Calculated and Responsive Bidder (SCRB),

WHEREFORE, the PRC Regional Office XI Regional Bids and Awards Committee, RESOLVED, as it is hereby RESOLVED, to recommend to the HOPE of PRC XI to award the contract to DAVAO ONE WORLD DIAGNOSTIC CENTER, INC., with an amount of Php120,780.00, for the Procurement of RT-PCR Test Service of PRC - RO XI Examination Personnel for the conduct of various Licensure Examinations for July 2022, for PRC Regional Office XI.
