RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE DECLARATION OF FAILURE OF BIDDING FOR THE PROCUREMENT OF FLEET CARD PAYMENT SYSTEM WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF TWO MILLION SIX HUNDRED EIGHTY SEVEN THOUSAND ONE HUNDRED FIFTY ONE PESOS AND SIXTY SEVEN CENTAVOS (PHP2,687,151.67)

WHEREAS, by the virtue of the invitation to apply for eligibility to bid through Public Bidding published in the PRC website, in the Philippine Government Electronic Procurement System (PhilGEPS) and the Bids and Awards Committee (BAC) Bulletin Board for the project: Procurement of Fleet Card Payment System with a Total Approved Budget for the Contract (ABC) of Two Million Six Hundred Eighty-Seven Thousand One Hundred Fifty-One Pesos and Sixty-Seven Centavos (Php2,687,151.67).

WHEREAS, on February 15, 2018 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. However, no prospective bidder attended the conference.

WHEREAS, the BAC issued Bid Bulletins No. 1 and 2, for the re-scheduling of 2nd Pre-Bid Conference from February 28, 2018 to March 2, 2018 and the postponement of the scheduled Opening of Bids from March 12, 2018 to March 14, 2018.

WHEREAS, no bidder bought the bidding documents, thus, caused the failure of bidding for the above stated project.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) provides for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with all the bid requirements as prescribed, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) **No bids are received;**
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or post-qualification, or x x x x (Emphasis supplied)

WHEREAS, Section 35.3 of the same IRR provide for the steps and procedure that the BAC should take in case of failure of bidding; x x x

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.^(a) (underscore supplied)

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to RECOMMEND TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, TO DECLARE A FAILURE OF BIDDING FOR THE PROCUREMENT OF FLEET CARD PAYMENT SYSTEM WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF TWO MILLION SIX HUNDRED EIGHTY SEVEN THOUSAND ONE HUNDRED FIFTY ONE PESOS AND SIXTY SEVEN CENTAVOS (PHP2,687,151.67). Consequently, the BAC shall revisit the terms, conditions, and specifications of the Fleet Card Payment System and conduct a re-bidding with re-advertisement and/or posting of said procurement project.
