RESOLUTION NO. 2018- 16(c)

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE DECLARATION OF SECOND FAILURE OF BIDDING FOR THE PROCUREMENT OF FLEET CARD PAYMENT SYSTEM - REBID WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF TWO MILLION SIX HUNDRED EIGHTY SEVEN THOUSAND ONE HUNDRED FIFTY ONE PESOS AND SIXTY SEVEN CENTAVOS (PHP2,687,151.67)

WHEREAS, the bidding for the Project: Procurement of Fleet Card Payment System was declared for the first time as failed on March 14, 2018, through the approved Bids and Awards Committee (BAC) Resolution No. 11(A), Series of 2018, (ANNEX "A").

WHEREAS, the BAC caused the re-posting of the Invitation to apply for eligibility and to bid through Public Bidding in the PRC website, in the Philippine Government Electronic Procurement System (PhilGEPS) and the Bids and Awards Committee (BAC) Bulletin Board for the project: Procurement of Fleet Card Payment System-Rebid with an Approved Budget for the Contract (ABC) of Two Million Six Hundred Eighty Seven Thousand One Hundred Fifty One Pesos and Sixty Seven Centavos (Php2,687,151.67).

WHEREAS, on March 27, 2018 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, however, no prospective bidder attended the conference.

WHEREAS, during the opening of bids on April 10, 2018, held at the PRC Conference Room, 2nd Floor, PRC Main Bldg., no bidder submitted its bid, thus, caused the failure of bidding for the above stated project.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) provides for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with all the bid requirements as prescribed, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) **No bids are received;**
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or post-qualification, or x x x (Emphasis supplied)

WHEREAS, Section 35.5 of the same IRR provides for the steps and procedure in the occurrence of a second failure of bidding; x x x

35.5. Should there occur a second failure of bidding, the Procuring Entity may resort to negotiated procurement, as provided in Section 53.1 of this IRR. (Underscore supplied)

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to RECOMMEND TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, TO DECLARE A SECOND FAILURE OF BIDDING FOR THE PROCUREMENT OF FLEET CARD PAYMENT SYSTEM WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF TWO MILLION SIX HUNDRED EIGHTY SEVEN THOUSAND ONE HUNDRED FIFTY ONE PESOS AND SIXTY SEVEN CENTAVOS (PHP2,687,151.67). Consequently, the BAC shall revisit the terms, conditions, and specifications of the Fleet Card Payment System and conduct a re-bidding with re-advertisement and/or posting of said procurement project through Negotiated Procurement under Section 53.1 Two Failed Biddings.
