Resolution No. 2019 - 11

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF CONTRACT FOR THE PRINTING AND SHREDDING OF TEST BOOKLETS FOR LOT 1 - MARCH 24, 2019 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS TO VIBAL GROUP, INC. WITH THE TOTAL BID AMOUNT OF FIVE MILLION TWO HUNDRED FIFTY EIGHT THOUSAND SIX HUNDRED SEVENTY TWO PESOS AND SIXTEEN CENTAVOS (PHP5,258,672.16)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the BAC Bulletin Board for the project: Printing and Shredding of Test Booklets for the March 24, 2019 and September 29, 2019 Licensure Examinations for Professional Teachers and for the November 29, 30 and December 1, 2019 Licensure Examination for Criminologists: Lot 1 – March 24, 2019 Licensure Examination for Professional Teachers, with an approved budget for the contract of Five Million Three Hundred Fifty Nine Thousand Eight Hundred Seventy Three Pesos (Php5,359,873.00).

WHEREAS, on January 16, 2019, a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, and was attended by two (2) prospective bidders namely: Vibal Group, Inc. (Vibal) and Velprint Corporation. However, only Vibal purchased the Bid Documents.

WHEREAS, on January 29, 2019, the deadline for submission and Opening of Bids, Vibal submitted its eligibility, technical and financial requirements.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, upon evaluation of the eligibility and technical documents submitted by Vibal, the BAC finds the same to be compliant or have passed the requirements.

WHEREAS, Vibal having passed the eligibility and technical evaluation, the BAC opened its financial bid proposal with the total bid amount of Five Million Two Hundred Fifty Eight Thousand Six Hundred Seventy Two Pesos and Sixteen Centavos (Php5,258,672.16) or Fifty Two Centavos (Php.52) per page for the printing and Two Pesos and Thirty Centavos (Php2.30) per set for the shredding.

WHEREAS, Vibal was declared as the Single Calculated Bidder and subjected to post-qualification on January 30, 2019 at its principal office address at 1253 G. Araneta Avenue, cor. Ma. Clara Street, Quezon City.

WHEREAS, during the post qualification, the BAC verified, validated and ascertained all statements made, and the documents submitted by the bidder during the submission and opening of bids in its Eligibility, Technical and Financial Envelopes. However, the bidder was not able to present copies of remittances for the December 2018 Pag-Ibig Fund and Social Security System (SSS) payments and November to December 2018 for the Philippine Health Insurance Corporation (PhilHealth) contributions of their employees. Hence, the bidder was given three (3) days to comply with the lacking requirements.

WHEREAS, on February 1, 2019, Vibal submitted copies of the remittances and completed their post qualification requirements.

WHEREAS, Vibal passed the post-qualification, and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PRINTING AND SHREDDING OF TEST BOOKLETS FOR LOT 1 - MARCH 24, 2019 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS** to **VIBAL GROUP, INC.**, with the total bid amount of **FIVE MILLION TWO HUNDRED FIFTY EIGHT THOUSAND SIX HUNDRED SEVENTY TWO PESOS AND SIXTEEN CENTAVOS (PHP5,258,672.16)**.
