RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE PROVISION OF SECURITY SERVICES FOR CALENDAR YEAR 2019 TO ABC-RMO SECURITY & INVESTIGATION AGENCY, INC. WITH A BID AMOUNT OF SIX MILLION NINE HUNDRED TWENTY ONE THOUSAND ONE HUNDRED SIXTY NINE PESOS AND SEVENTY ONE CENTAVOS (Php.6,921,169.71)

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the PRC website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the Bids and Awards Committee (BAC) Bulletin Board, only ABC-RMO Security & Investigation Agency, Inc. (ABC-RMO) participated in the Public Bidding for the project: Provision of Security Services for Calendar Year 2019 with an approved budget for the contract of Eight Million One Hundred Eighty Five Thousand Four Hundred Twenty Two Pesos (Php.8,185,422.00).

WHEREAS, the BAC issued Bid Bulletin No. 1 amending part of Section VII on the Technical Specifications with additional set of Technical Parameters and Section VIII on the Official Financial Bid Form.

WHEREAS, on November 22, 2018, a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, and was attended by lone prospective bidder namely, ABC-RMO Security & Investigation Agency, Inc. (ABC-RMO). Thus, only ABC-RMO purchased the bid documents.

WHEREAS, during the Opening of Bids on December 4, 2018, ABC-RMO submitted its bid containing their eligibility, technical, and financial requirements.

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, ABC-RMO having passed the eligibility and technical evaluation, the BAC opened the financial bid proposal of ABC-RMO amounting to **SIX MILLION NINE HUNDRED TWENTY ONE THOUSAND ONE HUNDRED SIXTY NINE PESOS AND SEVENTY ONE CENTAVOS** (Php6,921,169.71). Hence, ABC-RMO was declared to be the Single Calculated Bidder and was subjected to post-qualification on December 12, 2018.

WHEREAS, during the post qualification, the BAC verify, validate and ascertain all statement made, and documents submitted by the bidder during the submission and opening of bids in its Eligibility, Technical and Financial Envelopes including the additional documentary requirements that will be submitted by the said bidder during post-qualification.

WHEREAS, ABC-RMO, passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROVISION OF SECURITY SERVICES FOR CALENDAR YEAR 2019** to **ABC-RMO SECURITY & INVESTIGATION AGENCY, INC.** with the bid amount of **SIX MILLION NINE HUNDRED TWENTY ONE THOUSAND ONE HUNDRED SIXTY NINE PESOS AND SEVENTY ONE CENTAVOS (Php.6,921,169.71).**
