TERMS OF REFERENCE

SUPPLY AND DELIVERY OF PURIFIED DRINKING WATER AND PROVISION OF HOT AND COLD WATER DISPENSERS FOR PROFESSIONAL REGULATION COMMISSION CAGAYAN DE **ORO REGIONAL OFFICE X (PRC-X)**

(Through Negotiated Procurement under Section 53.9 Small Value Procurement of the 2016 Revised IRR of R.A. 9184)

I. Approved Budget for the Contract:

The PRC-X intends to apply the sum amount of Fifty Thousand Pesos Only (₱50,000.00) being the ABC of the aforesaid procurement. The bid prices/s should not exceed the ABC of each item inclusive of all applicable taxes, bank, government charges, and other similar charges. Bids received in excess of the ABCs shall be automatically disgualified during bid evaluation.

11. **Specifications:**

- a. The supplier shall deliver clean, safe and healthy to drink Purified Drinking Water which is equivalent to five (5) gallons per container to the PRC-X located at 2nd floor Skypark. Limketkai Center, Cagayan de Oro City;
- b. The containers shall be made of food grade material and must be tamper-proof to protect from contamination;
- c. The supplier shall deliver forty (40) containers, with five (5) gallons per container, on a weekly basis or four (4) times a month delivery [4 x 40 containers = 160 containers per month] or as may be required by PRC-X, delivery is free of charge;
- d. An additional number of containers per month might be requested by PRC-X from time to time, aside from that mentioned above and PRC-X will inform the supplier in writina:
- e. The supplier must provide and install with free of use of four (4) units of hot and cold water dispensers without cost to the PRC-X;
- The supplier must maintain and check the installed water f. dispensers every three (3) months and immediately replace defective water dispensers or as needed;
- g. The water dispensers and 5-gallons per container shall remain properties of the Supplier for exclusive use of purified drinking water. Negligence and improper use of the said dispensers and containers, as proven, resulting to major damage and/or loss shall be at the expense of PRC-X;
- h. The supplier must furnish a copy of all necessary permits and licenses to operate to PRC-X.
