





TERMS OF REFERENCE (TOR)

PROCUREMENT OF 2022 PRC CALENDAR

(Through Negotiated Procurement Pursuant to Section 53.9 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184)

I. Approved Budget for the Contract

The supplier shall bid for the item described in this Terms of Reference, which shall not exceed the Approved Budget for the Contract (ABC) in the amount of One Hundred Fifty-Three Thousand Nine Hundred Ninety-Six Pesos (Php153,996.00) inclusive of all applicable bank and government charges.

II. Background

The Professional Regulation Commission (PRC) is the official government body responsible for qualifying and ensuring the competence of professionals in the country. It administers examinations for admission to practice the professions under its jurisdiction.

Pursuant to Section 7 (d) of R. A. 8981, authorizing the Commission to determine and fix the places and dates of examinations, the Commission issued Resolution No. 1439 (s. 2021) scheduling the licensure examinations for calendar year 2022, including the opening of online processing, deadlines for filing of applications, practical examinations and target dates of release of examination results.

For information dissemination of the said schedule of examinations and related activities, and for the guidance of the offices/divisions and stakeholders of the Commission, the Year 2022 PRC Calendar shall be procured with the following terms and conditions.

III. Scope of Service

The service provider shall be able to provide the printing of the Year 2022 PRC Calendar.

IV. Qualification Requirements

- The service provider must previously have the same transaction with any government agency;
- The service provider shall only use the design and lay-out provided by the end-user. The first printed calendar shall be presented to the end-user for approval prior to mass production; and
- The service provider shall deliver the items within thirty (30) calendar days from the receipt of Contract.
