**BIDS AND AWARDS COMMITTEE
RESOLUTION NO. 2022 - 145(A)**

**RECOMMENDING TO THE CHAIRPERSON OF THE PROFESSIONAL
REGULATION COMMISSION, FOR HER APPROVAL, THE AWARD OF CONTRACT
TO GAKKEN (PHILIPPINES), INC. THROUGH DIRECT CONTRACTING FOR THE
PROCUREMENT OF DUPLO PARTS AND CONSUMABLES - LOT 1 -
PROCUREMENT OF DUPLO PARTS FOR DUPLO COPIER MACHINE DPS550
WITH THE BID AMOUNT OF TWENTY- EIGHT THOUSAND THREE HUNDRED
PESOS (PHP28,300.00)**

WHEREAS, the Rating Division requested for the Procurement of Duplo Parts that must be compatible with the existing Duplo Copier Machine DPS550 in order to maintain the performance and effectiveness of the said copier machine.

WHEREAS, Section 48 of Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) provide that the procuring entity may resort to any of the alternative methods of procurement; provided that, in all instances, the procuring entity shall ensure that the most advantageous price for the Government is obtained.

WHEREAS, Section 50 of the IRR of RA No. 9184, among others, allows direct contracting or single source procurement under the following conditions:

"(a) Procurement of goods of proprietary nature which can be obtained only from the proprietary source, i.e. when patents, trade secrets, and copyrights prohibit others from manufacturing the same item;

(c) Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP. "

WHEREAS, GAKKEN (Philippines), Inc. (GAKKEN), is the exclusive sales distributor for all Duplo Products in the Philippines for the Year 2022. Thus, GAKKEN is also authorized to sell relevant Duplo branded consumables, spare parts, and maintenance services in line with the above said products, as issued by Duplo Corporation (Japan), (Annex "A").

WHEREAS, on October 17, 2022, the Bids and Awards Committee (BAC), with the end-user, conducted evaluation of the proposal of GAKKEN. Upon evaluation, GAKKEN passed the eligibility and technical evaluation with the financial bid quotation of Twenty-Eight Thousand Three Hundred Pesos (Php28,300.00).

WHEREAS, under the specific guidelines for Direct Contracting, simplified negotiations on the terms and conditions of the contract may be conducted by the BAC to ensure that the supplier is technically, legally and financially capable to deliver the goods at the most advantageous price and contract for the Government.


WHEREAS, GAKKEN has offered to supply and deliver Duplo Parts for Duplo Copier Machine DPS550 with the total amount of Twenty-Eight Thousand Three Hundred Pesos (Php28,300.00).



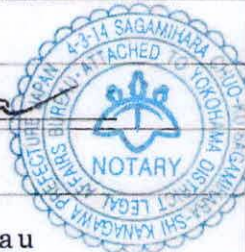
