**Resolution No. 2022 - 21**

**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE SUPPLY, PRINTING, AND DELIVERY OF QUALITY GUIDEBOOK WITH USB STICK TO ZURBANO PUBLISHING & PRINTING CORP. WITH TOTAL BID AMOUNT OF EIGHT HUNDRED FORTY-FOUR THOUSAND SEVEN HUNDRED EIGHTY PESOS (PHP844,780.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System, and Bids and Awards Committee (BAC) Bulletin Board for the project: Supply, Printing, and Delivery of Quality Guidebook with USB Stick with an approved budget for the contract of Nine Hundred Thousand Pesos (Php900,000.00).

**WHEREAS**, on 8 April 2022, during the schedule of submission and opening of bids, only one bidder submitted its quotation, namely: Zurbano Publishing & Printing Corp. (ZPPC).

**WHEREAS**, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act, requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

**WHEREAS**, upon evaluation of the submitted eligibility documents, using a non-discretionary “pass/fail” criterion, ZPPC passed the eligibility and technical evaluation, with financial bid quotation amounting to Eight Hundred Forty-Four Thousand Seven Hundred Eighty Pesos (Php844,780.00).


**WHEREAS**, ZPPC was declared as the Single Calculated and Responsive Bidder.

**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the project: **SUPPLY, PRINTING, AND DELIVERY OF QUALITY GUIDEBOOK WITH USB STICK** to **ZURBANO PUBLISHING & PRINTING CORP.** with the total bid amount of **EIGHT HUNDRED FORTY-FOUR THOUSAND SEVEN HUNDRED EIGHTY PESOS (PHP844,780.00)**.


