DECLARATION OF FAILURE OF BIDDING FOR THE PROJECT: LEASE OF VENUE FOR THE CONDUCT OF PRB OF LIBRARIAN'S INTERNATIONAL CONFERENCE UNDER THE INTERNATIONAL COMMITMENTS FUND 2022 WITH AN APPROVED BUDGET FOR THE CONTRACT OF FOUR MILLION FIVE HUNDRED TWELVE THOUSAND FIVE HUNDRED PESOS (Php4,512,500.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.10 (Lease of Real Property and Venue) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 was posted in the website and social media account of the Commission and at the Bids and Awards Committee (BAC) Bulletin Board for the project: Lease of Venue for the Conduct of Professional Regulatory Board (PRB) of Librarian's International Conference under the International Commitments Fund 2022 with an approved budget for the contract of Four Million Five Hundred Twelve Thousand Five Hundred Pesos (Php4,512,500.00);

WHEREAS, as stated in the Terms of Reference, several establishments located within the National Capital Region were requested to submit quotation for the project through electronic mail, namely: HOTEL H20, THE BELLEVUE MANILA, and DIAMOND HOTEL PHILIPPINES;

WHEREAS, during the scheduled deadline and submission of bid proposals on 18 November 2022 at 9:00 o'clock in the morning, **no bidder submitted a bid proposal**, thus, caused the failure of bidding for the above stated project;

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (IRR) provides for the authority of the BAC to declare a failure of bidding in cases where no bidders responded to the request for quotation, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;
- b) All prospective bidders are declared ineligible;
- *c)* All bids fail to comply with all the bid requirements or postqualification, or x xxx (Emphasis supplied)

WHEREAS, Sections 35. 2 and 35.3 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

- 35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.
- 35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a rebidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING for the project: LEASE OF VENUE FOR THE CONDUCT OF PRB OF LIBRARIAN'S INTERNATIONAL CONFERENCE UNDER THE INTERNATIONAL COMMITMENTS FUND 2022 with an approved budget for the contract of Four Million Five Hundred Twelve Thousand Five Hundred Pesos (Php4,512,500.00).

Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project upon request by the End-User.
