DECLARATION OF SECOND FAILURE OF BIDDING FOR THE PROCUREMENT OF CUSTOMIZED CERTIFICATE HOLDER AND CUSTOMIZED PRC PIN: LOT 1 CUSTOMIZED CERTIFICATE HOLDER - REBID WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF FOURTEEN THOUSAND PESOS (Php14,000.00) THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 – SMALL VALUE PROCUREMENT

WHEREAS, the bidding for the project: Procurement Customized Certificate Holder and Customized PRC Pin: Lot 1 Customized Certificate Holder – Rebid was declared for the first time as failed on August 30, 2022, through the approved Bids and Awards Committee (BAC) Resolution No. 2022-79.

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission and at the Bids and Awards Committee (BAC) Bulletin Board for the project: Procurement of Customized Certificate Holder and Customized PRC Pin: Lot 1 – Customized Certificate Holder - Rebid with an approved budget for the contract of Fourteen Thousand Pesos (Php14,000.00) only.

WHEREAS, during the scheduled deadline and submission of bid proposal on December 5, 2022, no bidder submitted its bid proposal.

WHEREAS, Section 35, Rule X of the 2016 Revised IRR provides for the authority of the BAC to declare a failure of bidding in cases where no bidders responded to the request for quotation, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) **No bids are received;**
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or post-qualification, or x xxx (Emphasis supplied)

WHEREAS, Section 35. 2 and 35.3 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.(a) (underscoring supplied).


WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A SECOND FAILURE OF BIDDING FOR THE PROCUREMENT OF CUSTOMIZED CERTIFICATE HOLDER AND CUSTOMIZED PRC PIN: LOT 1 – CUSTOMIZED CERTIFICATE HOLDER - REBID with a total approved budget for the contract of FOURTEEN THOUSAND PESOS (Php14,000.00).
