**RECOMMENDING FOR THE APPROVAL OF THE OFFICER-IN-CHARGE OF
THE PROFESSIONAL REGULATION COMMISSION, THE AWARD OF
CONTRACT FOR THE PROJECT: PROCUREMENT OF VARIOUS PRC PLAQUES
FOR PRC AWARDEES FOR THE 2ND SEMESTER OF THE YEAR 2022 - REBID TO
ALPHA QUALITY EXPRESS INC. WITH TOTAL BID AMOUNT OF FIFTY-SIX
THOUSAND TWENTY-THREE PESOS AND THIRTY-THREE CENTAVOS
(PHP56,023.33)**

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website and social media account of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Various PRC Plaques for PRC Awardees for the 2nd Semester of the Year 2022 - Rebid with an approved budget for the contract of Fifty-Six Thousand Twenty-Three Pesos and Thirty-Three Centavos (Php56,023.33).

WHEREAS, several service providers were also requested through e-mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, only one (1) bidder participated and submitted its eligibility, technical, and financial proposal, namely, Alpha Quality Express Inc., (AQEI).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the “Government Procurement Reform Act”, requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

WHEREAS, on 28th of November 2022, during the opening and evaluation of bids, E&C passed the eligibility and technical evaluation with the financial bid quotation of Fifty-Six Thousand Twenty-Three Pesos and Thirty-Three Centavos (Php56,023.33) and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE **RESOLVES**, as it hereby **RESOLVED**, to recommend for approval of the Officer-in-Charge of the Professional Regulation Commission, the award of contract for the project: **PROCUREMENT OF VARIOUS PRC PLAQUES FOR PRC AWARDEES FOR THE 2ND SEMESTER OF THE YEAR 2022 - REBID** to **ALPHA QUALITY EXPRESS INC.** with the total bid amount of **FIFTY-SIX THOUSAND TWENTY-THREE PESOS AND THIRTY-THREE CENTAVOS (PHP56,023.33).**
