**RECOMMENDING FOR THE APPROVAL OF THE CHAIRPERSON OF THE
PROFESSIONAL REGULATION COMMISSION, THE AWARD OF CONTRACT
FOR THE PROJECT: PROCUREMENT OF 2023 PRC CALENDAR TO ZURBANO
PUBLISHING & PRINTING CORP. WITH TOTAL BID AMOUNT OF TWO
HUNDRED FOURTEEN THOUSAND EIGHT HUNDRED THIRTY-SIX PESOS
(PHP214,836.00)**

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website and social media account of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of 2023 PRC Calendar with an approved budget for the contract of Two Hundred Twenty-Four Thousand Four Hundred Sixty-Seven Pesos (Php224,467.00).

WHEREAS, several service providers were also requested through e-mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, two (2) bidders participated and submitted their eligibility, technical, and financial proposals, namely, Zurbano Publishing & Printing Corp. (Zurbano) and AJ & TJ Printing (AJ & TJ).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".


WHEREAS, on 14 December 2022, during the opening and evaluation of bids using a non-discretionary "pass/fail" criterion, AJ & TJ failed to submit a valid Mayor's Permit/Business Permit, and also failed to completely accomplish the information needed in Annex "B" or the financial bid form. Thus, AJ and TJ was declared disqualified.


WHEREAS, Zurbano passed the eligibility and technical evaluation, with the financial bid quotation of Two Hundred Fourteen Thousand Eight Hundred Thirty-Six Pesos (Php214,836.00) and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE **RESOLVES**, as it hereby **RESOLVED**, to recommend for approval of the Chairperson of the Professional Regulation Commission, the award of contract for the project: **PROCUREMENT OF 2023 PRC CALENDAR to ZURBANO PUBLISHING & PRINTING CORP.** with the total bid amount of **TWO HUNDRED FOURTEEN THOUSAND EIGHT HUNDRED THIRTY-SIX PESOS (PHP214,836.00).**
