Resolution No. 2022 - **18(A)**

**DECLARATION OF FAILURE OF BIDDING FOR THE PROCUREMENT OF HEAVY DUTY PLATFORM TROLLEY WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF TEN THOUSAND PESOS (PHP10,000.00) THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 – SMALL VALUE PROCUREMENT**

**WHEREAS**, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, and in the Bids Awards Committee (BAC) Bulletin Board for the project: Procurement of Heavy Duty Platform Trolley with an approved budget for the contract of Ten Thousand Pesos (Php10,000.00) only.

**WHEREAS**, during the opening of the bid document on April 20, 2022, held at 4<sup>th</sup> Floor, PRC Annex Building, no bidder submitted its eligibility and technical requirements.

**WHEREAS**, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (IRR) provides for the authority of the BAC to declare a failure of bidding in cases where no bids are received, to wit:

**Section 35. Failure of Bidding**

35.1 The BAC shall declare the bidding a failure when:

- a) **No bids are received;**
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or post-qualification, or xxx (Emphasis supplied)

**WHEREAS**, Section 35. 2 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.

**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to **DECLARE A FAILURE OF BIDDING FOR THE PROCUREMENT OF HEAVY DUTY PLATFORM TROLLEY** with a total approved budget for the contract of **TEN THOUSAND PESOS (PHP10,000.00)**. **Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.**
