Resolution No. 2022 - **18(A)**

DECLARATION OF FAILURE OF BIDDING FOR THE PROCUREMENT OF HEAVY DUTY PLATFORM TROLLEY WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF TEN THOUSAND PESOS (PHP10,000.00) THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 – SMALL VALUE PROCUREMENT

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, and in the Bids Awards Committee (BAC) Bulletin Board for the project: Procurement of Heavy Duty Platform Trolley with an approved budget for the contract of Ten Thousand Pesos (Php10,000.00) only.

WHEREAS, during the opening of the bid document on April 20, 2022, held at 4th Floor, PRC Annex Building, no bidder submitted its eligibility and technical requirements.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (IRR) provides for the authority of the BAC to declare a failure of bidding in cases where no bids are received, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or post-qualification, or x xxx (Emphasis supplied)

WHEREAS, Section 35. 2 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING FOR THE PROCUREMENT OF HEAVY DUTY PLATFORM TROLLEY with a total approved budget for the contract of TEN THOUSAND PESOS (PHP10,000.00). Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.
