Resolution No. 2022 - 157

RECOMMENDING TO THE CHAIRPERSON OF THE PROFESSIONAL REGULATION COMMISSION, FOR HER APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF NINE (9) UNITS OF REFRIGERATORS TO M4DREW CONSUMER GOODS TRADING WITH A TOTAL BID AMOUNT OF ONE HUNDRED TWENTY THOUSAND THREE HUNDRED NINETY-THREE PESOS (Php120,393.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website and social media account of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Nine (9) Units of Refrigerators with an approved budget for the contract of One Hundred Twenty-Six Thousand Pesos (Php126,000.00) only.

WHEREAS, on December 19, 2022 during the schedule of submission and opening of bids, five (5) bidders participated and submitted their eligibility, technical, and financial proposals, namely, Double N Prime Enterprises, OPC (Double N Prime), Brilliant Light Trading and Electrical Services (Brilliant), M4drew Consumer Goods Trading (M4drew), MCSA Marketing (MCSA), and Apex Office Supplies and Equipment Trading (APEX).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, known as the Government Procurement Reform Act, requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

WHEREAS, on 19 December 2022, during the opening and evaluation of bids, using a non-discretionary “pass/fail” criterion, Double N Prime, Brilliant, and MCSA were declared disqualified due to the following reasons:

1. Double N Prime failed to submit a duly accomplished and notarized Secretary's Certificate, thus, the person signed the Terms of Reference (Annex “A”) and Financial Bid (Annex “B”), has no authority to represent the corporation;
2. Brilliant failed to submit a duly signed Omnibus Sworn Statement (OSS), it also failed to submit an authorization to sign as representative, thus, the person signed the Terms of Reference (Annex “A”) and Financial Bid (Annex “B”), has no authority to represent the company; and
3. MCSA failed to submit an Omnibus Sworn Statement (OSS), it also failed to submit an authorization to sign as representative, thus, the person signed the Terms of Reference (Annex “A”) and Financial Bid (Annex “B”), has no authority to represent the company;

WHEREAS, M4drew passed the eligibility and technical evaluation, with a financial bid quotation of One Hundred Twenty Thousand Three Hundred Ninety-Three Pesos (Php120,393.00).

WHEREAS, on the scheduled opening and evaluation of bids on December 19, 2022, the quotation of APEX was not opened due to failure on the part of the BAC Secretariat to endorse their quotation to the BAC members.


WHEREAS, on December 20, 2022, as per advise of the Government Procurement Policy Board (GPPB) the BAC proceeded in the opening and evaluation of bids of APEX. APEX passed the eligibility and technical evaluation, with a financial bid quotation of One Hundred Twenty-Five Thousand Pesos (Php125,000.00).

WHEREAS, M4drew, having the lowest financial bid quotation, was declared as the Lowest Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairperson of the Professional Regulation Commission, for her approval, the award of contract for the **PROCUREMENT OF NINE (9) UNITS OF REFRIGERATORS** to **M4DREW CONSUMER GOODS TRADING** with the bid amount of **ONE HUNDRED TWENTY THOUSAND THREE HUNDRED NINETY-THREE PESOS (Php120,393.00)**.


