DECLARATION OF FAILURE OF BIDDING FOR THE PROCUREMENT OF NON-CSE VARIOUS OFFICE SUPPLIES AND EQUIPMENT FOR BOOKBINDING WITH AN APPROVED BUDGET FOR THE CONTRACT OF SEVENTY-ONE THOUSAND AND EIGHTY-THREE PESOS (71,083.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Non-CSE Various Office Supplies and Equipment for Bookbinding with an approved budget for the contract of Seventy-One Thousand and Eighty-Three Pesos (Php71,083.00).

WHEREAS, several providers of necessary supplies and equipment for building repair and maintenance were also invited through electronic mail to submit a proposal.

WHEREAS, prior the scheduled deadline and submission of bid quotation, only Ban Bee Commercial Co., Inc. (BBCCI), submitted its bid proposal through electronic mail on 04 June 2022.

WHEREAS, during the evaluation of bid quotation on 06 June 2022 at 9:30 in the morning, it was verified that the submitted bid proposal by BBCCI was signed by unauthorized representative, therefore given a failed marking in the submission of Secretary's Certificate/Authorization to sign as representative for the company and in the Financial Bid Form.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (IRR) provides for the authority of the BAC to declare a failure of bidding in cases where no bidders responded to the request for quotation, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;*
- b) All prospective bidders are declared ineligible;***
- c) All bids fail to comply with all the bid requirements or post-qualification, or x xxx (Emphasis supplied)***

WHEREAS, Sections 35. 2 and 35.3 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the

ABC, subject to the required approvals, and conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING FOR THE PROCUREMENT OF NON-CSE VARIOUS OFFICE SUPPLIES AND EQUIPMENT FOR BOOKBINDING with a total approved budget for the contract of SEVENTY-ONE THOUSAND AND EIGHTY-THREE PESOS (71,083.00). Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project upon request by the End-User.
