Resolution No. 2022 - 64

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF VARIOUS IT EQUIPMENT: LOT 1 – ONE (1) DATABASE RACKMOUNT SERVER TO TERABIT COMPUTER SYSTEMS CORPORATION WITH TOTAL BID AMOUNT OF EIGHT HUNDRED NINETEEN THOUSAND EIGHT HUNDRED THIRTY-FIVE PESOS (Php819,835.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Various IT Equipment: Lot 1 – One (1) Database Rackmount Server with an approved budget for the contract of Nine Hundred Fourteen Thousand Pesos (Php914,000.00).

WHEREAS, on July 18, 2022, during the schedule of submission and opening of bids, four (4) bidders submitted their quotations, namely: McSA Marketing (McSA), Terabit Computer Systems Corporation (TERABIT), SIM Computer Sales Inc. (SIM), and Imax Technologies Inc. (IMAX).

WHEREAS, during the opening and evaluation of bid, using a non-discretionary “pass/fail” criterion. McSA and SIM were declared disqualified due to the following reasons:

1. McSA failed to submit the Mayor's/Business Permit, PhilGEPS Registration Number, Latest Income/Business Tax Return, Omnibus Sworn Statement, Secretary's Certificate, and Annex A of the Request for Quotation (RFQ);
2. SIM provided the total bid amount of Php1,160,000.00 and failed to provide a breakdown of bid amount per lot.

WHEREAS, TERABIT and IMAX both passed the eligibility and technical evaluation, with the following financial bid quotations:

1. Terabit Computer Systems Corporation – Php819,835.00
2. IMAX Technologies Incorporated – Php839,296.00

WHEREAS, TERABIT was declared to be the Lowest Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission for his approval the award of the contract for the project: **PROCUREMENT OF VARIOUS IT EQUIPMENT: LOT 1 – DATABASE RACKMOUNT SERVER to TERABIT COMPUTER SYSTEMS CORPORATION** with a total bid amount of **EIGHT HUNDRED NINETEEN THOUSAND EIGHT HUNDRED THIRTY-FIVE PESOS (Php819,835.00)**
