**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF FIVE (5) UNITS LOCKER CABINET TO IKF HOME FURNISHING AND OFFICE FURNITURE WITH TOTAL BID AMOUNT OF FORTY-EIGHT THOUSAND FOUR HUNDRED NINETY-FIVE PESOS (Php48,495.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Five (5) Units Locker Cabinet with an approved budget for the contract of Sixty Thousand Pesos (Php60,000.00).

**WHEREAS**, on June 1, 2022, during the schedule of submission and opening of bids, four (4) bidders submitted their quotations, namely: FURN APT Design Corporation (FURN), RDSK Furniture Supply (RDSK), Valeriano Enterprise (Valeriano Ent.), and IKF Home Furnishing and Office Furniture (IKF).

**WHEREAS**, during the opening and evaluation of bid, using a non-discretionary “pass/fail” criterion. Valeriano Ent. failed to submit the Secretary’s Certificate/Authorization to sign as representative, the submitted Omnibus Sworn Statement is unsigned, and not compliant to some of the specifications indicated in Annex A of the Request for Quotation (RFQ) while FURN, RDSK, and IKF passed the eligibility and technical evaluation, with the following financial bid quotations:

1. FURN APT Design Corp. – Php56,080.00
2. RDSK Furniture Supply – Php50,500.00
3. IKF Home Furnishing and Office Furniture – Php48,495.00

**WHEREAS**, IKF was declared to be the Lowest Calculated and Responsive Bidder.

**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission for his approval the award of the contract for the project: **PROCUREMENT OF FIVE (5) UNITS LOCKER CABINET to IKF HOME FURNISHING AND OFFICE FURNITURE** with total bid amount of **FORTY-EIGHT THOUSAND FOUR HUNDRED NINETY-FIVE PESOS (Php48,495.00)**.
