



BIDS AND AWARDS COMMITTEE Resolution No. 2022 - <u>33</u>

DECLARATION OF FAILURE OF BIDDING FOR THE PROCUREMENT OF AIR PURIFIER FOR VARIOUS PRC OFFICES (LOT 1 – 5) WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF SEVENTY-SEVEN THOUSAND NINE HUNDRED FORTY-NINE PESOS (PHP77,949.00) THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 – SMALL VALUE PROCUREMENT

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 - Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Air Purifier for Various PRC Offices (Lot 1 - 5) with an approved budget for the contract of Seventy-Seven Thousand Nine Hundred Forty-Nine Pesos (Php77,949.00) only.

WHEREAS, during the scheduled deadline and submission of bid proposals on June 06, 2022 at 8:00 o'clock in the morning, no bidder submitted a bid proposal, thus caused the failure of bidding for the project.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (IRR) provides for the authority of the BAC to declare a failure of bidding in cases where no bidders responded to the request for quotation, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or postqualification, or x xxx (Emphasis supplied)

WHEREAS, Section 35. 2 and 35.3 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

- 35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.
- 35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a rebidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING FOR THE PROCUREMENT OF AIR PURIFIER FOR VARIOUS PRC OFFICES (LOT 1 – 5) with a total approved budget for the contract of SEVENTY-SEVEN THOUSAND NINE HUNDRED FORTY-NINE PESOS (PHP77,949.00). Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.
