RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE SUPPLY, PRINTING AND DELIVERY OF FY 2022 MID-YEAR PERFORMANCE ASSESSMENT (MYPA) AND RE-PLANNING CONFERENCE CORPORATE MATERIALS/KITS TO ZURBANO PUBLISHING AND PRINTING CORP. WITH TOTAL BID AMOUNT OF SEVEN HUNDRED TWENTY-FOUR THOUSAND EIGHT HUNDRED PESOS (PHP724,800.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, and at the Bids and Awards Committee (BAC) Bulletin Board for the project: Supply, Printing and Delivery of FY 2022 Mid-Year Performance Assessment (MYPA) and Re-Planning Conference Corporate Materials/Kits with an approved budget for the contract of Eight Hundred Thousand Four Hundred Fifteen Pesos (P800,415.00).

WHEREAS, several service providers were also requested through e-mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, only Meraki Digital Printing Services (Meraki Digital) and Zurbano Publishing and Printing Corp. (Zurbano Publishing) participated and submitted its eligibility, technical, and financial proposal.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

WHEREAS, on 27 June 2022, during the opening and evaluation of bids, Meraki Digital was declared disqualified for it failed to submit the complete form for the Annex “A” and failed to complete the information required in Annex “B” of the Request for Quotation.

WHEREAS, Zurbano Publishing during the said opening and evaluation of bids passed the eligibility and technical evaluation with the financial bid quotation of Seven Hundred Twenty-Four Thousand Eight Hundred Pesos (Php724,800.00), and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE **RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the project: **SUPPLY, PRINTING AND DELIVERY OF FY 2022 MID-YEAR PERFORMANCE ASSESSMENT (MYPA) AND RE-PLANNING CONFERENCE CORPORATE MATERIALS/KITS** to **ZURBANO PUBLISHING AND PRINTING CORP.** with the total bid amount of **SEVEN HUNDRED TWENTY-FOUR THOUSAND EIGHT HUNDRED PESOS (PHP724,800.00)**
