Resolution No. 2022 - 68(A)

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF NETWORK TOOL SET AND 2 BAY NETWORK ATTACHED STORAGE: LOT 1 – TWENTY (20) SETS OF NETWORK TOOL SET TO SIM COMPUTER SALES, INC. WITH TOTAL BID AMOUNT OF TWO HUNDRED FORTY THOUSAND PESOS (Php240,000.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Network Tool Set and 2 Bay Network Attached Storage: Lot 1 – Twenty (20) sets of Network Tool Set with an approved budget for the contract of Two Hundred Fifty Thousand Pesos (Php250,000.00).

WHEREAS, several service providers were also requested through e-mail to submit quotation for the project.

WHEREAS, on August 10, 2022, during the schedule of submission and opening of bids, five (5) bidders submitted their quotations, namely: The Value Systems Integration Inc. (TVSII), Bridgecom Enterprises Co., Inc. (BRIDGECOM), Aukchoi Cosumer Goods Traiding (AUKCHOI), SIM Computer Sales Inc. (SIM), and Imax Technologies Inc. (IMAX).

WHEREAS, during the opening and evaluation of bid, using a non-discretionary “pass/fail” criterion. TVSII, BRIDGECOM, and IMAX were declared disqualified due to to the following reasons:

1. TVSII submitted an unnotarized Secretary's Certificate;
2. BRIDGECOM submitted an unsigned and unnotarized Secretary's Certificate;
3. IMAX provided the total bid amount of Php355,300.00 which is higher than the approved budget for the contract.

WHEREAS, AUKCHOI and SIM both passed the eligibility and technical evaluation, with the following financial bid quotations:


1. AUKCHOI – Php248,000.00
2. SIM – Php240,000.00

WHEREAS, SIM was declared to be the Lowest Calculated and Responsive Bidder.


WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of the contract for the project: **PROCUREMENT OF NETWORK TOOL SET AND 2 BAY NETWORK ATTACHED STORAGE: LOT 1 – NETWORK TOOL SET to SIM COMPUTER SALES, INC.** with a total bid amount of **TWO HUNDRED FORTY THOUSAND PESOS (Php240,000.00)**


