**RECOMMENDING FOR THE APPROVAL OF THE CHAIRPERSON OF THE
PROFESSIONAL REGULATION COMMISSION, THE AWARD OF CONTRACT FOR
THE PROCUREMENT OF 4 TERABYTE SERIAL ADVANCED TECHNOLOGY
ATTACHMENT HARD DISK DRIVE TO IMAX TECHNOLOGIES INC. WITH A TOTAL
BID AMOUNT OF TWO HUNDRED EIGHTY-NINE THOUSAND THREE HUNDRED
TWENTY PESOS (PHP289,320.00)**

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System, and Bids and Awards Committee (BAC) Bulletin Board for the project: Procurement of 4 Terabyte Serial Advanced Technology Attachment Hard Disk Drive (TB SATA HDD) with an approved budget for the contract of Three Hundred Sixty-Nine Thousand Six Hundred Eighty Pesos (Php369,680.00);

WHEREAS, several prospective bidders were also requested through e-mail to submit quotation for the project;

WHEREAS, prior the deadline for submission and opening of bids, eleven (11) bidders participated and submitted their eligibility, technical, and financial proposals namely: ABLAZE MARKETING (ABLAZE), ACXESSPOINT I.T. SOLUTIONS INC. (ACXESSPOINT), IMAX TECHNOLOGIES INC. (IMAX), BAYANPC TECHNOLOGIES, INC. (BayanPC), SIM COMPUTER SALES, INC. (SIM), IVALUE TECHNOLOGIES CORPORATION (IVALUE), ARTJOHNLEY ENTERPRISES (ARTJOHNLEY), MAXCORE TECHNOLOGIES INC. (MAXCORE), J1TEK TRADING CORPORATION (J1TEK), TITUS118 NON-SPECIALIZED WHOLESALE TRADING (TITUS118), and ePARTNERS SOLUTIONS, INC. (ePARTNERS);

WHEREAS, on 18 August 2022, during the evaluation of bids using a non-discretionary “pass/fail” criterion, the BAC declared bidders ABLAZE, ACXESSPOINT, BayanPC, ARTJOHNLEY, MAXCORE, and J1TEK disqualified, due to the following findings:

1. ABLAZE failed to submit a duly notarized Special Power of Attorney to the signatory of their bid proposal;
2. ACXESSPOINT, failed to submit Omnibus Sworn Statement and Secretary's Certificate to the signatory in the Terms of Reference (Annex “A”) and Financial Bid (Annex “B”) of its bid proposal as authorize representative of its company;
3. BayanPC failed to submit a duly notarized Secretary's Certificate;
4. ARTJOHNLEY submitted an unsigned Omnibus Sworn Statement;
5. MAXCORE also failed to submit a duly notarized Secretary's Certificate; and
6. J1TEK also failed to submit Omnibus Sworn Statement and Secretary's Certificate to the signatory in the Terms of Reference (Annex “A”) and Financial Bid (Annex “B”) of its bid proposal as authorize representative of its company.

WHEREAS, IMAX, SIM, IVALUE, TITUS118, and ePARTNERS passed the eligibility and technical evaluation with the following financial bid quotations:

1. **IMAX – Php289,320.00**
2. SIM – Php340,000.00
3. IVALUE – Php332,800.00
4. TITUS118 – Php369,680.00
5. ePARTNERS – Php311,520.00


WHEREAS, IMAX offered the lowest bid quotation was declared to be the Lowest Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE **RESOLVES**, as it hereby **RESOLVED**, to recommend for approval to the Chairperson of the Professional Regulation Commission, the award of contract for the project: 4TB SATA HDD to IMAX TECHNOLOGIES INC. with the total bid amount of TWO HUNDRED EIGHTY-NINE THOUSAND THREE HUNDRED TWENTY PESOS (PHP289,320.00)
