BIDS AND AWARDS COMMITTEE Resolution No. 2022 - 103

RECOMMENDING TO THE CHAIRPERSON OF THE PROFESSIONAL REGULATION COMMISSION, FOR HER APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF WEBSITE MAINTENANCE - SSL CERTIFICATE TO GMO GLOBALSIGN INC. WITH A TOTAL BID AMOUNT OF ONE HUNDRED TWENTY FOUR THOUSAND FIVE HUNDRED FIFTY SIX PESOS AND FIFTY FOUR CENTAVOS (PHP124,556.54)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System (PhilGEPS), and Bids and Awards Committee (BAC) Bulletin Board for the project: Procurement of Website Maintenance - SSL Certificate with an Approved Budget for the Contract (ABC) of Two Hundred Ten Thousand Pesos (Php210,000.00).

WHEREAS, on September 20, 2022 a pre-bid conference via video conferencing was held to explain and clarify the Request for Quotation (RFQ) and to accommodate any inquiry which the bidders may have. This was attended only by one (1) prospective bidder, GMO Globalsign Inc. (Globalsign).

WHEREAS, on September 21, 2022, the BAC issued Bid Bulletin No. 1 in regard to the modification and amendment in the Annex A of the RFQ and was posted in PhilGEPS, PRC Website and BAC Bulletin Board.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on October 3, 2022, during the submission and opening of bids, only Globalsign and Terabit Computer Systems Corporation (Terabit) submitted their quotations. Upon evaluation, Globalsign passed the eligibility and technical evaluation with the financial bid quotation of One Hundred Twenty Four Thousand Five Hundred Fifty Six Pesos And Fifty Four Centavos (Php124,556.54). On the other hand, Terabit failed to submit a copy of the duly acknowledged Bid Bulletin No. 1 as part of its bid and Terabit was declared disqualified. Thus, Globalsign was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairperson of the Professional Regulation Commission, for her approval, the award of contract for the PROCUREMENT OF WEBSITE MAINTENANCE - SSL CERTIFICATE TO GMO GLOBALSIGN INC. WITH A TOTAL BID AMOUNT OF ONE HUNDRED TWENTY FOUR THOUSAND FIVE HUNDRED FIFTY SIX PESOS AND FIFTY FOUR CENTAVOS (PHP124,556.54).
