DECLARATION OF FAILURE OF BIDDING FOR THE PROJECT: LEASE OF VENUE FOR THE CONDUCT OF PRB OF PSYCHOLOGIST'S INTERNATIONAL CONFERENCE UNDER INTERNATIONAL COMMITMENTS FUND 2022 WITH AN APPROVED BUDGET FOR THE CONTRACT OF TWO MILLION SEVEN HUNDRED THIRTY-ONE THOUSAND SIX HUNDRED EIGHTY-THREE PESOS AND THIRTY-THREE CENTAVOS (PHP2,731,683.33)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.10 (Lease of Real Property and Venue) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 was posted in the website of the Commission and at the Bids and Awards Committee (BAC) Bulletin Board for the project: Lease of Venue for the Conduct of PRB of Psychologist's International Conference under International Commitments Fund 2022 with an approved budget for the contract of Two Million Seven Hundred Thirty-One Thousand Six Hundred Eighty-Three Pesos and Thirty-Three Centavos (Php2,731,683.33).

WHEREAS, several establishments from the preferred location of venue stated in the Terms of Reference (TOR) were also invited through electronic mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, only BELLE SOUTH PACIFIC PROPERTIES INC. (BSPPI), submitted a bid proposal.

WHEREAS, on 28 September 2022 at 9:30 in the morning during the evaluation of bids using a non- discretionary "pass/fail" criterion, the BAC declared BSPPI disqualified for the Secretary's Certificate issued does not include in the authority provided by the corporation to their authorized representative to participate in other agencies. The submitted Secretary Certificate limits the authority of their representative to execute and perform any act and all acts to represent the company to sign, apply, request any and all documents needed and required by the Provincial Government of Bohol.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (IRR) provides for the authority of the BAC to declare a failure of bidding in cases where no bidders responded to the request for quotation, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or

post-qualification, or x xxx (Emphasis supplied)

WHEREAS, Sections 35. 2 and 35.3 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

- 35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.
- 35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a rebidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING for the project: LEASE OF VENUE FOR THE CONDUCT OF PRB OF PSYCHOLOGIST'S INTERNATIONAL CONFERENCE UNDER INTERNATIONAL COMMITMENTS FUND 2022 with an approved budget for the contract of Two Million Seven Hundred Thirty-One Thousand Six Hundred Eighty-Three Pesos and Thirty-Three Centavos (Php2,731,683.33).

Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project upon request by the End-User.
